OH	H.571	Introduced	<ul style="list-style-type: none"> Creates presumption that COVID-19 contracted by law enforcement officer, firefighter or emergency medical worker during state of emergency is work-related
OH	H.605	Introduced	<ul style="list-style-type: none"> Creates presumption that COVID-19 contracted by employee in food retail or food processing establishment during state of emergency is work-related
TX	Dept. of Insurance		<ul style="list-style-type: none"> Temporarily provides reimbursement of reasonable medical expenses for public safety employees who were likely exposed to COVID-19 in course of employment
WI	Proposal from Governor		<ul style="list-style-type: none"> Proposes to create presumption for “critical workers” that COVID-19 is work-related
