weeks. **The way the bill is currently written, 5G is a Trojan Horse, concealed inside the term “broadband.”** We believe that most legislators do not understand this.

Please contact committee members listed below as well as your own Senator(s) to ask them to amend the language in Bill H.513 to:

1. Remove Bill H. 513 Sections 19a (1) and (2) because they allow 5G to be implemented under the cover of broadband expansion.
2. Place a stay on the attachment of 5G antennas to poles and towers until proven safe and reliable, including 4G antennas that can be upgraded to 5G via software.
