14	number four, five, and six residual oil for utility and nonutility uses. "Heating
15	fuel" means a fossil or renewable fuel that is used for heating a building,
16	including a residence, business, or commercial or industrial building or
17	structure. For purposes of this chapter, electricity shall not be considered a
18	heating fuel.
19	(3) "Primary storage facility" or "facility" means any facility or terminal
20	with a capacity of 50,000 gallons or more which receives petroleum products
21	by ship, barge, pipeline, truck, or rail, for holding within the State.
