1	(a) Appropriation. The sum of \$100,000.00 is appropriated to the Agency

5	under the Vermont Community Development Act.
6	(b) Public safety planning grants.
7	(1) Public safety planning grants are created for the purpose of fostering
8	regional public safety planning.
9	(2) A regional organization, such as a regional planning commission,
10	union municipal district, joint survey committee, or other qualified
11	organization may apply to the Agency for a public safety planning grant for the
12	purpose of planning the integration, consolidation, or regionalization of public
13	safety functions within the organization's jurisdiction. A grant shall be for a
14	maximum of three years and shall not exceed \$35,000.00, and shall be
15	provided to grantees in different geographic regions of the State.
16	(3) A grantee shall be required to report annually on or before January
17	15 to the Senate and House Committees on Government Operations and on
18	Appropriations regarding its planning process and expected result. Each report
19	shall specifically provide data on and analyze the potential costs and savings of
20	regional consolidation of public safety functions.

1	(A)(i) "Planning" means hiring personnel or contracting for services
2	to determine the feasibility of or to establish the procedure to implement, or
