

SUMMARY OF ACCOMPLISHMENTS 2017 through 2019

Security Systems

\$1,289,123 of the Capitol Appropriations has been executed to fund security systems projects. (123% increase since 2017)

- 27 Buildings received complete packages (Security cameras, building lockdown and panic/alarm systems). (107% increase since 2017)
- 37 buildings received (or are in progress) of receiving appropriate security packages and upgrades



BGS Security Systems Integration Unit has completed approximately 497 work orders (tracked since 1/1/2018). 79% of all requests for emergency service were responded to within 48 hours.



Threat Investigator.

In November 2019, State Safety and Security hired a full-time Threat Investigator. In only two months 87 potential threat incidents were reviewed. 19 threats resulted in investigations and interviews. Potential victims from all 19 cases were provided with a personalized threat mitigation plans.

Emergency Procedures for the Individual State Employee:


- 2372 employees have completed Emergency Preparedness trainings since 2017.

73 more are registered for near-future classes Buildings were prioritized by Threat Level and we've targeted those in the highest threat (1 and 2+) moving down to low threat level (2, 3, 4). We are currently moving to Threat Level 2 and 3.

Emergency Procedures Plans (EPP) for State Buildings



Infant in the Workplace inspections

In 2019, State Safety and Security received 17 Infant in the Workplace Requests and conducted safety and security risk assessments. These assessments identified whether the building where the infant would be placed had an Emergency Plans in place, what types of threats had been received at the building and made additional workplace safety recommendations. State Safety and Security has infant headphones available to parents to check out for the duration of the infant stay.

The EPP Process

- 1. Meet with Building Leadership (Bldg Safety Committee) to include representatives from each tenant agency/dept.
- 2. Begin the plan development
- 3. Train ECM and Safety Wardens, all staff
- 4. Finalize plan
- 5. Conduct tabletop exercise and after-action review
- 6. Conduct drill and after-action review

ANNEX B THREAT MITIGATION

The BGS Threat Mitigation Specialist works to prevent targeted violence or threats of violence toward state employees or facilities by engaging in interagency coordination and partnerships.

The Threat Mitigation Specialist prevents targeted violence toward state employees and facilities under the jursidiction of the Commissioner of Building and General Services.

The three key functions of the program are:

(1) identifying those that might pose a threat;

(2) investigating and assessing those individuals; and

(3) implementing a mitigation strategy designed to prevent an attack. Utilizing a behavior-based methodology.

These investigations are often lengthy in nature and focused more on mitigation of the threat as opposed to prosecution. Threat investigations require a unique set of investigative strategies that often times vary from other types of prosecutable offenses. The BGS State Safety and Security has initiated an all encompassing review of the D3 Incident Reporting System.
