**SUBJECT:** Executive Branch Seasonal Temporary Employee Report – CY 2019

As required by 3 V.S.A. § 331(c)3, the enclosed report consists of the number of positions in seasonal employment that have been authorized for a period of between seven and 12 months during the prior calendar year, the agency or department for each temporary or seasonal position, and the period of time that each identified position is authorized.

In calendar year 2019, there were 12 such authorizations granted. One of these positions transitioned to classified service before reaching seven months. Two additional positions did not reach seven months prior to termination.



**Per 3 VSA 311(3)**

**(A) the total number of positions in seasonal employment that have been authorized for a period of between seven and 12 months during the prior calendar year;**

**(B) the agency or department that each position identified in subdivision (A) of this subdivision (c)(3) is assigned to; and**
