4	reports that it has considered the same and recommends that the bill be

7	Sec. 1. 26 V.S.A. chapter 31 is amended to read:
8	CHAPTER 31. PHYSICIAN ASSISTANTS
9	§ 1731. POLICY AND PURPOSE
10	The General Assembly recognizes the need to provide means by which
11	physicians in this State may increase the scope and physician assistants may
12	practice medicine in collaboration with physicians and other health care
13	professionals to provide increased efficiency of their practice in order and to
14	ensure that quality high-quality medical services are available to all
15	Vermonters at reasonable cost. The General Assembly recognizes that
16	physician assistants, with their education, training, and expertise in the field of
17	medicine, are well suited to provide these services to Vermonters.
18	§ 1732. DEFINITIONS
19	As used in this chapter:
20	(1) "Accredited physician assistant program" means a physician
21	assistant educational program that has been accredited by the Accreditation

1	Review Commission on Education for the Physician Assistant (ARC-PA), or,
2	prior to 2001, by either the Committee on Allied Health Education and
3	Accreditation (CAHEA), or the Commission on Accreditation of Allied Health
4	Education Programs (CAAHEP).
5	(2) "Board" means the State Board of Medical Practice established by
6	chapter 23 of this title.
7	(3) "Delegation agreement" means a detailed description of the duties
8	and scope of practice delegated by a primary supervising physician to a
9	physician assistant that is signed by both the physician assistant and the
10	supervising physicians. "Collaboration" means a physician assistant's
11	consultation with or referral to an appropriate physician or other health care
12	professional as indicated based on the patient's condition; the physician
13	assistant's education, competencies, and experience; and the applicable
14	standards of care.
15	(4) "Disciplinary action" means any action taken by the Board against a
16	physician assistant or an applicant, or an appeal of that action, when the action
17	suspends, revokes, limits, or conditions licensure in any way. The term
18	includes reprimands and administrative penalties.
19	(5) "Health care facility" has the same meaning as in 18 V.S.A. § 9402.
20	(6) "Participating physician" means a physician practicing as a sole
21	practitioner, a physician designated by a group of physicians to represent their

1	physician group, or a physician designated by a health care facility to represent
2	that facility, who enters into a practice agreement with a physician assistant in
3	accordance with this chapter.
4	(7) "Physician" means an individual licensed to practice medicine
5	pursuant to chapter 23 or 33 of this title.
6	(5)(8) "Physician assistant" or "PA" means an individual licensed by the
7	State of Vermont who is qualified by education, training, experience, and
8	personal character to provide medical care with the direction and supervision
9	of a Vermont licensed physician to practice medicine in collaboration with one
10	or more physicians pursuant to this chapter.
11	(9) "Physician group" means a medical practice involving two or more
12	physicians.
13	(6)(10) "Supervising physician" means an M.D. or D.O. licensed by the
14	state of Vermont who oversees and accepts responsibility for the medical care
15	provided by a physician assistant "Practice agreement" means an agreement
16	that meets the requirements of section 1735a of this chapter.
17	(7)(11) "Supervision" means the direction and review by the supervising
18	physician of the medical care provided by the physician assistant. The
19	constant physical presence of the supervising physician is not required as long
20	as the supervising physician and physician assistant are or easily can be in
21	contact with each other by telecommunication "Practice as a physician

1	assistant" means the practice of medicine by a PA pursuant to a practice
2	agreement with a participating physician.
3	(8) "Disciplinary action" means any action taken against a physician
4	assistant or an applicant by the Board or on appeal therefrom, when that action
5	suspends, revokes, limits, or conditions licensure in any way, and includes
6	reprimands and administrative penalties.
7	§ 1733. LICENSURE
8	(a) The State Board of Medical Practice is responsible for the licensure of
9	physician assistants, and the Commissioner of Health shall adopt, amend, or
10	repeal rules regarding the training, practice, qualification, and discipline of
11	physician assistants.
12	(b) In order to practice, a licensed physician assistant shall have completed
13	a delegation agreement as described in section 1735a of this title with a
14	Vermont licensed physician signed by both the physician assistant and the
15	supervising physician or physicians. The original shall be filed with the Board
16	and copies shall be kept on file at each of the physician assistant's practice
17	sites. All applicants and licensees shall demonstrate that the requirements for
18	licensure are met.

- (a) The Board may grant a license to practice as a physician assistant to an
 applicant who meets all of the following requirements:
 - (1) <u>submits</u> a completed application form provided by the <u>board</u>; Board.
 - (2) pays Pays the required application fee;
 - (3) has Has graduated from an accredited physician assistant program or has passed and maintained the certification examination by the National Commission on the Certification of Physician Assistants (NCCPA) prior to 1988;.
 - (4) has <u>Has</u> passed the <u>certification examination given Physician</u>
 <u>Assistant National Certifying Examination administered</u> by the NCCPA;
 - (5) is <u>Is</u> mentally and physically able to engage safely in practice as a physician assistant;
 - (6) does <u>Does</u> not hold any license, certification, or registration as a physician assistant in another state or jurisdiction that is under current disciplinary action, or has been revoked, suspended, or placed on probation for cause resulting from the applicant's practice as a physician assistant, unless the Board has considered the applicant's circumstances and determines that licensure is appropriate;
 - (7) is <u>Is</u> of good moral character;

- (8) <u>submits</u> to the Board any other information that the Board deems necessary to evaluate the applicant's qualifications; and.
- (9) has <u>Has</u> engaged in practice as a physician assistant within the last three years or has complied with the requirements for updating knowledge and skills as defined by Board rules. This requirement shall not apply to applicants who have graduated from an accredited physician assistant program within the last three years.
- (b), (c) [Repealed.]
- (d) When the Board intends to deny an application for licensure, it shall send the applicant written notice of its decision by certified mail. The notice shall include a statement of the reasons for the action. Within 30 days of the date that an applicant receives such notice, the applicant may file a petition with the Board for review of its preliminary decision. At the hearing, the burden shall be on the applicant to show that licensure should be granted. After the hearing, the Board shall affirm or reverse its preliminary denial.
- (e) Failure to maintain competence in the knowledge and skills of a physician assistant, as determined by the Board, shall be cause for revocation of licensure.

19 § 1734b. RENEWAL OF LICENSE

(a) Licenses shall be renewed every two years on payment of the required fee. At least one month prior to the date on which renewal is required, the

Board shall send to each licensee a license renewal application form and notice of the date on which the existing license will expire. On or before the renewal date, the licensee shall file an application for license renewal and pay the required fee. The Board shall register the applicant and issue the renewal license. Within one month following the date renewal is required, the Board shall pay the license renewal fees into the Medical Practice Board Special Fund. Any physician assistant while on extended active duty in the uniformed services of the United States or member of the National Guard, State Guard, or reserve component as a member of the U.S. Armed Forces, a reserve component of the U.S. Armed Forces, the National Guard, or the State Guard who is licensed as a physician assistant at the time of an activation or deployment the licensee was ordered to active duty shall receive an extension of licensure up to 90 days following the physician assistant's return from activation or deployment active duty, provided the physician assistant notifies the Board of his or her activation or deployment that the licensee has been ordered to active duty prior to the expiration of the current license, and certifies that the circumstances of the activation or deployment duty impede good faith efforts to make timely application for renewal of the license. (b) A licensee shall demonstrate that the requirements for licensure are met.

(c) A licensee for renewal of an active license to practice shall have

practiced as a physician assistant within the last three years or have complied

3	(d) A licensee shall promptly provide the Board with new or changed

1	§ 1735a. SUPERVISION PRACTICE AGREEMENT AND SCOPE OF

3	(a) It is the obligation of each team of physician and physician assistant to
4	ensure that the physician assistant's scope of practice is identified; that
5	delegation of medical care is appropriate to the physician assistant's level of
6	competence; that the supervision, monitoring, documentation, and access to the
7	supervising physician is defined; and that a process for evaluation of the
8	physician assistant's performance is established A Except as provided in
9	subsections 1734c(b) and 1735a(e) of this chapter, a physician assistant who

1	(b) The information required in subsection (a) of this section shall be
2	included in a delegation agreement as required by the Commissioner by rule.
3	The delegation agreement shall be signed by both the physician assistant and
4	the supervising physician or physicians, and a copy shall be kept on file at each
5	of the physician assistant's practice sites and the original filed with the Board
6	A practice agreement shall include all of the following:
7	(1) Processes for physician communication, availability, decision-
8	making, and periodic joint evaluation of services delivered when providing
9	medical care to a patient.
10	(2) An agreement that the physician assistant's scope of practice shall be
11	limited to medical care that is within the physician assistant's education,
12	training, and experience. Specific restrictions, if any, on the physician
13	assistant's practice shall be listed.
14	(3) A plan for contacting other physicians for consultation in
15	situations in which the participating physician is a sole practitioner and is
16	not available for consultation to have a physician available for
17	consultation at all times when the physician assistant is practicing
18	medicine.
19	(4) The signatures of the physician assistant and the participating
20	physician; no other signatures shall be required.

(c) The physician assistant's scope of practice shall be limited to medical
care which is delegated to the physician assistant by the supervising physician
and performed with the supervision of the supervising physician. The medical
care shall be within the supervising physician's scope of practice and shall be
care which the supervising physician has determined that the physician
assistant is qualified by education, training, and experience to provide A
practice agreement may specify the extent of the collaboration required
between the PA and the participating physician and between the PA
physicians and other health care professionals; provided, however, that a
physician shall be accessible for consultation by telephone or electronic means
at all times when a PA is practicing.
(d) The practice agreement shall be reviewed by the physician assistant and
either the participating physician or a representative of the practice, physician
group, or health care facility, at a minimum, at the time of the physician
assistant's license renewal.
(d)(e) In the event of the unanticipated unavailability of a participating
physician practicing as a sole practitioner due to serious illness or death, a
physician assistant may continue to practice for not more than a 30-day period
without entering into a new practice agreement with another participating
physician.

1	(f) The practice agreement shall not be submitted to the Board for
2	approval or filing but shall be maintained by the physician assistant and
3	provided to the Board upon request shall be filed with the Board. The
4	Board shall not request or require any modifications to the practice
5	agreement. The practice agreement may be filed with the Board
6	electronically at the option of the physician assistant; no original
7	documents shall be required.
8	(g) Nothing in this section shall be construed to require the physical
9	presence of a physician at the time and place at which a physician assistant
10	renders a medical service.
11	(h) A physician assistant may prescribe, dispense, and administer, and
12	procure drugs and medical devices to the extent delegated by a supervising
13	physician to the same extent as may a physician. A physician assistant who is
14	authorized by a supervising physician to prescribe prescribes controlled

16	Enforcement Administration.
17	(e) A supervising physician and physician assistant shall report to the

2	Notwithstanding any provision of law to the contrary, a physician assistant
3	shall be considered a primary care provider when the physician assistant

6	§ 1736. UNPROFESSIONAL CONDUCT
7	(a) The following conduct and the conduct described in section 1354 of this

13	occasion or on multiple occasions. Failure to practice competently includes, as

15	(A) performance of unsafe or unacceptable patient care; or

18	(c) A person aggrieved by a determination of the Board may, within 30		
19	days of the order, appeal that order to the Vermont Supreme Court on the basis

§ 1738. USE OF TITLE

Any person who is licensed to practice as a physician assistant in this State shall have the right to use the title "physician assistant" and the abbreviation "P.A." abbreviations "PA" and "PA-C." No other person may shall assume that title, or use that abbreviation those abbreviations, or use any other words, letters, signs, or devices to indicate that the person using them is a physician assistant.

§ 1739. LEGAL LIABILITY

- (a) The supervising physician delegating activities to a physician assistant shall be legally liable for such activities of the physician assistant, and the physician assistant shall in this relationship be the physician's agent.
- (b) Nothing in this chapter shall be construed as prohibiting a physician from delegating to the physician's employees certain activities relating to medical care and treatment now being carried out by custom and usage when such activities are under the control of the physician. The physician delegating activities to his or her employees shall be legally liable for such activities of such persons, and such person shall in this relationship be the physician's agent. Nothing contained in this chapter shall be construed to apply to nurses acting pursuant to chapter 28 of this title. Physician assistants are responsible for their own medical decision making. A participating physician in a practice agreement with a physician assistant shall not, by the existence of the practice
