10	a child, sexual assault, human trafficking, aggravated human trafficking,
11	murder, manslaughter, arson causing death, and kidnapping may be
12	commenced at any time after the commission of the offense.
13	(b) Prosecutions for manslaughter, lewd and lascivious conduct, sexual
14	abuse of a vulnerable adult <u>under subsection 1379(a) of this title</u> , <u>maiming</u> ,
15	first degree aggravated domestic assault, grand larceny, robbery, burglary,
16	embezzlement, forgery, bribery offenses, false claims, fraud under 33 V.S.A. §
17	141(d), and felony tax offenses shall be commenced within six years after the
18	commission of the offense, and not after.
19	(c) Prosecutions for any of the following offenses shall be commenced
20	within 40 years after the commission of the offense, and not after:

1	(1) lewd and lascivious conduct alleged to have been committed against
2	a child under 18 years of age;

6	(4) sexual exploitation of children under chapter 64 of this title; and
7	(5) manslaughter alleged to have been committed against a child under
8	18 years of age; and
9	sexual abuse of a vulnerable adult under subsection 1379(b) of this title.
10	(d) Prosecutions for arson shall be commenced within 11 years after the
11	commission of the offense, and not after.
12	(e) Prosecutions for other felonies and for misdemeanors shall be
13	commenced within three years after the commission of the offense, and not
14	after.
