2 Senators Bray and Mazza move that the bill be amended by striking out all
3 after the enacting clause and inserting in lieu thereof the following:

4 * * * Motor Vehicles Subject to the Emissions Inspection * * *

5 Sec. 1. 23 V.S.A. § 1222(a) is amended to read:

6 (a) Except for school buses, which shall be inspected as prescribed in
7 section 1282 of this title, and motor buses as defined in subdivision 4(17) of
8 this title, which shall be inspected twice during the calendar year at six-month
9 intervals, all motor vehicles registered in this State shall ~~be inspected~~ undergo
10 a safety and visual emissions inspection once each year and all motor vehicles
11 that are registered in this State and are 15 model years old or less shall undergo
12 an on board diagnostic (OBD) systems inspection once each year as applicable.
13 Any motor vehicle, trailer, or semi-trailer not currently inspected in this State
14 shall be inspected within 15 days following the date of its registration in the
15 State of Vermont.

16 * * * Rulemaking and Implementation * * *

17 Sec. 2. RULEMAKING

18 (a) Within six months after the effective date of this section, the
19 Commissioner of Motor Vehicles, in consultation with the Agency of Natural
20 Resources, shall file with the Secretary of State a proposed amended rule
21 governing vehicle inspections in this State (Periodic Inspection Manual) that is

1 consistent with federal law, including 40 C.F.R. part 51, subpart S,
2 **[DELETED establishes a goal of a waiver rate of less than three percent,]**
3 and only requires an on board diagnostic (OBD) systems inspection once each
4 year, as applicable, for motor vehicles registered in this State that are 15 model
5 years old or less.

6 Sec. 3. IMMEDIATE IMPLEMENTATION

7 (a) Notwithstanding 10 V.S.A. § 567(a), as soon as practicable after the
8 effective date of this section, the Commissioner of Motor Vehicles shall update
9 the content of inspections conducted through the Automated Vehicle
10 Inspection Program to exclude any requirements of the Periodic Inspection
11 Manual that are inconsistent with the amendments to 23 V.S.A. § 1222 in Sec.
12 1 of this act, with the effect that no motor vehicle that is more than 15 model
13 years old will be required to undergo an on board diagnostic (OBD) systems
14 inspection.

15 (b) In the event that the Commissioner cannot update the content of
16 inspections conducted through the Automated Vehicle Inspection Program in
17 accordance with subsection (a) of this section within 45 days after the effective
18 date of this section, the Commissioner shall, within 45 days after the effective
19 date of this section, develop and implement a temporary work-around to ensure
20 that no motor vehicle that is more than 15 model years old will be required to
21 undergo an OBD systems inspection.

15 Sec. 5. EFFECTIVE DATES

16 (a) This section and Secs. 2 (rulemaking) and 3 (implementation) shall take
17 effect on passage.

18 (b) Sec. 1 (inspection program) shall take effect 45 days after passage.

19 (c) Sec. 4 (inspection program) shall take effect 30 days after the later of:

20 (1) the adoption of the rule governing vehicle inspections in this State
21 (Periodic Inspection Manual) in conformance with Sec. 2 of this act; or

- 1 (2) the approval of the State’s state implementation plan addressing its
- 2 inspection and maintenance (I/M) program by the Environmental Protection
- 3 Agency.
