The Agency of Agriculture, Food and Markets (AAFM) makes this report to the Legislative committees of jurisdiction and the Appropriations committees as require in ACT 138. This report includes information on the distribution of grant funds appropriated to date, the amount of grant funds that remains available for distribution, and its plans for awarding the available funds on or before December 20, 2020 within Act 138, Act 137, and Act 120.

# **Dairy Producer and Processor Assistance Application**

The Vermont COVID Agricultural Assistance Program - Dairy Producer and Processor Program application was built and launched on July 17, 2020 and the table below shows data on the activity within this application.

As of August 31, 2020, 261 applicants have initiated an application – they have accessed the application in the online portal and are entering data for their dairy business. An additional 200 applications have been submitted and received and are in process of review, revision, pending approval, approval, and award by the AAFM. The table below show the data broken out by dairy business size category.

<b>Payment Dairy Applications</b>			

The total amount available for the Dairy Processors is \$3,800,000 and as of August 31, 2020, \$302,862.05 has been approved which is 7.97% of the total appropriation available.

The total amount available for Dairy Producers is \$21,200,000 and as of August 31, 2020, \$4,141,361.56 has been approved which is 19.53% of the total appropriation available.

Outreach to dairy producers and processors is on-going to encourage all eligible to apply by September 30, 2020. To further assist dairy producer and processor applicants, four Application Tips Sessions are scheduled between August 31 and September 3. These sessions will address solutions for technical challenges and commonly occurring application struggles for dairy applicants. AAFM will share

successful tips on submitting a complete and successful application and hear from dairy businesses about their specific application submission experience.

The Legislation allows for a second application if the dairy processor or dairy producer has not reached the capped amount of payment on the award from the first application. The software functionality to authorize supplemental applications is being tested the week of August 31 with the goal of being live and available to eligible applicants by September 7, 2020. All eligible applicants that have applied and been awarded funding will be notified of their ability to apply again, what steps are required and that the deadline is September 30, 2020. Of the approved applications, the majority of the SFO, CSFO and a portion of the MFO would be able to apply again since the cap was not reached on their first application. For the dairy processors, the majority of the less than 500 lb/day, 500 to 10,000 lb/day and a portion of the 10,000 to 50,000 lb/day would be able to apply again since the cap was not reached on their first application.

### **Agricultural Fairs Assistance Application**

Vermont COVID-19 Agriculture Assistance Program Agriculture Fairs Application was open from July 31 through August 20, 2020. Applicants demonstrated economic losses and costs incurred after March 1, 2020 and before September 1, 2020 related to the COVID-19 public health emergency. Traditional fair events that fell outside of this time period were also eligible, based on the fair's date of cancellation. All Agricultural Fairs were contacted in advance of the application going live and encouraged to prepare the required documentation for this application. Staff also took 29 calls and responded to 25 emails regarding fair eligibility, assistance with technology, and clarification on eligible expenses.

Twelve applications were received from Agricultural Fairs and deemed eligible by the AAFM review team. The AAFM is finalizing the review of these applications and expenses this week. Once this is completed, the applicants will be notified of the grant amounts awarded, based on an equitable calculation of reported losses and incurred costs across all twelve eligible fairs. Grant payments will be completed via ACH by September 4, 2020.

#### **Agriculture and Working Lands Assistance Application**

The Agriculture and Working Lands Assistance Application launched on Wednesday August 19, 2020. This application includes funding outlined in Act 120 (\$1 million), Act 137 (\$2.5 million), and Act 138 (\$5 million). This combined application has \$8.5 million of CRF available for agriculture businesses (including farmers, commercial meat processors, commercial slaughterhouses, and farmers markets),

value-added food product businesses, forest products businesses, agriculture producer associations, and dairy producers and processors with expenses not eligible for coverage under the Dairy Assistance Application.

As of August 31, 2020, 113 applicants have initiated an application – they have accessed the application in the online portal and are entering data for their agriculture and working lands business. An additional 52 applications have been submitted and received and are in process of review, revision, pending approval, approval, and award by the AAFM. As of August 31, no Agriculture and Workings Lands Assistance Applications have been reviewed, approved, or processed for payment. This process is underway and will be a collaboration with Vermont Economic Development Authority (VEDA). We anticipate to finalize the capability in the online system and begin the review process during the week of August 31. The table below show the data broken out by business size category.

### **VCAAP Education and Outreach Efforts**

Extensive education and outreach activities have and are occurring for the three Vermont COVID-19 Agriculture Assistance Program Applications – dairy producers and processors, agricultural fairs, and agriculture and working lands. The listing below shows this activity which is on-going.

Nearly 700 direct emails and phone calls between AAFM staff and producers/processors/service providers with questions about the VT COVID-19 Agriculture Assistance Program (VCAAP) applications occurred during the period August 1-31, 2020.

- Specific questions related to individual prospective applicants
- When additional CRF grant funds will be available to other agricultural businesses
- Frequently asked questions from business advisors working directly with eligible businesses
- Access to webinars, FAQs, subject matter expert contacts regarding the various applicants.
