The enclosed provides a combined funding summary for the Vermont Low Income Home Weatherization Assistance Program administered by the Office of Economic Opportunity, Department for Children and Families – Dept ID 344011.

Page two provides a summary of expenditures and cash balance in the Home Weatherization Assistance Fund (Fuel Tax) and page 6 provides a summary of cash receipts for the Fund (i.e., fuel tax revenue).

Currently, the Weatherization Program relies on three revenue sources: Fuel Tax Revenue (Fund 21235), LIHEAP federal funds, and Department of Energy federal funds.

Beginning in SFY 2017, the Fuel Gross Receipts Tax changed to a Fuel Tax; in February 2018, the tax began being paid on a monthly basis instead of quarterly (July, October, January, April). The change to a monthly payment presumably led to a one-time bump in revenue for SFY 2017 (May and June).

SFY 2018 is the first fuel year with the new Fuel Tax rates and pay schedule.

SFY 2018 Fuel Tax Revenue - Actual: \$10,227,005

The unobligated cash balance on the fund at the end of SFY 2018 was \$239,084.

SFY 2019 Fuel Tax Revenue - Projected: \$10,374,429

The projected unobligated cash balance on the fund at the end of SFY 2019 is \$292,882.

The tables below describe Projected Revenue and Expenditures from the Home Weatherization Assistance Fund (Fuel Tax – Special Fund), as well as expenditures by funding source in the SFY2020 Governor’s Budget Recommendation.
