5 Statement of purpose of bill as introduced: This bill proposes to:

6 (a) make miscellaneous changes to laws related to vehicles;

7 (b) establish an automated vehicle testing program;

8 (c) require the Department of Motor Vehicles to (1) provide written forms,
9 applications, and tests used in operator licensing translated into the primary
10 language used in every nation from which individuals assisted by the U.S.

11 Committee for Refugees and Immigrants Vermont in the prior ten years hail

12 and (2) allow an applicant to have an individual of his or her choosing at the
13 oral examination or road test required for licensing to serve as an interpreter;
14 and

15 (d) require the Commissioner of Motor Vehicles to provide training on
16 recognizing and addressing cultural differences and other barriers to access to
17 Department of Motor Vehicles employees who directly interact with the
18 public.

17 § 607. JUNIOR OPERATOR'S LICENSE

18 (a) A junior operator's license may be issued initially only to persons who:

20 (3) have:

21 (A) possessed a learner's permit for not less than one year;

1 (B) submitted on a form provided by the Department of Motor
2 Vehicles which is approved by the Commissioner, and certified by the
3 operator's licensed parent or guardian, licensed or certified driver education
4 instructor, or licensed person at least 25 years of age that there ~~has been:~~
5 (i) was at least 40 hours of practice behind the wheel, at least 10 of
6 which ~~shall be~~ was nighttime driving; and that the operator was accompanied
7 by ~~their~~ his or her licensed parent or guardian, a licensed or certified driver
8 education instructor, or another licensed ~~person~~ individual at least 25 years of
9 age, riding ~~beside the operator in the front passenger seat~~; and

10 (ii)(C) ~~have~~ maintained a driving record without a learner's permit
11 suspension, revocation, or recall for six consecutive months prior to licensure.

13 (c) Any junior operator's license may be renewed. Notwithstanding the
14 provisions of any other law, a renewed junior operator's license shall not be

7 (e) Obtaining a commercial learner's permit is a precondition to the initial
8 issuance of a commercial driver license. The issuance of a commercial
9 learner's permit also is a precondition to the upgrade of a commercial driver
10 license if the upgrade requires a skills test. A permit may be issued to an
11 individual who holds a valid Vermont driver's license who has passed the
12 vision and written tests required for the class of license authorizing the
13 operation of the type of vehicle for which the permit application is being made.
14 A commercial learner's permit holder is not eligible to take the commercial
15 driver license skills test in the first 14 days after initial issuance of the
16 commercial learner's permit. A permit shall be issued for a period of ~~six~~

14 Sec. 15. 23 V.S.A. § 301 is amended to read:

15 § 301. PERSONS REQUIRED TO REGISTER

16 Residents, except as provided in chapter 35 of this title, shall annually
17 register motor vehicles owned or leased for a period of more than 30 days and
18 operated by them, unless currently registered in Vermont. Notwithstanding
19 this section, a resident who has moved into the State from another jurisdiction
20 shall register his or her motor vehicle within 60 days of moving into the State.

21 A person shall not operate a motor vehicle nor draw a trailer or semi-trailer on

1 any highway unless such vehicle is registered as provided in this chapter.
2 Vehicle owners who have apportioned power units registered in this State
3 under the International Registration Plan are exempt from the requirement to
4 register their trailers in this State.

6 Sec. 16. 23 V.S.A. chapter 41 is added to read:

7 CHAPTER 41. AUTOMATED VEHICLE TESTING

8 § 4201. SHORT TITLE

9 This chapter may be cited as the Automated Vehicle Testing Act.

10 § 4202. DEFINITIONS

11 As used in this chapter:

12 (1) “Automated driving system” means the hardware and software that
13 are collectively capable of performing the entire dynamic driving task on a
14 sustained basis, regardless of whether it is limited to a specific operational
15 design domain. This term is used specifically to describe a level 3, 4, or 5
16 driving automation system.

17 (2) “Automated vehicle” means a motor vehicle that is equipped with an
18 automated driving system that is designed to function at a level of driving
19 automation of level 3, 4, or 5 pursuant to SAE J3016. The term includes a
20 highly automated vehicle.

1 (3) “Automated vehicle tester” or “tester” means an individual,
2 company, public agency, or other organization that is testing automated
3 vehicles on public highways in this State pursuant to this chapter including but
4 not limited to an automated vehicle manufacturer, municipal or State agency,
5 institution of higher education, fleet service provider, or automotive equipment
6 or technology provider.

7 (4) “Dynamic driving task” means all the real-time operational and
8 tactical functions required to operate an automated vehicle in traffic on a
9 highway. The term does not include functions relating to planning for the use
10 of the vehicle, including the scheduling of a trip or the selection of a
11 destination or waypoint.

12 (5) “Highly automated vehicle” means a vehicle equipped with an
13 automated driving system that is designed to function at a level of driving
14 automation of level 4 or 5 pursuant to SAE J3016.

15 (6) “Manufacturer” means an individual or company that designs,
16 produces, or constructs vehicles or equipment. Manufacturers include original
17 equipment manufacturers (OEMs), multiple and final stage manufacturers,
18 individuals or companies making changes to a completed vehicle before first
19 retail sale or deployment (upfitters), and modifiers (individuals or companies
20 making changes to existing vehicles after first retail sale or deployment).

1 (7) “Minimal risk condition” means a condition in which an automated
2 vehicle operating without a human driver, upon experiencing a failure of its
3 automated driving system that renders the automated vehicle unable to perform
4 the dynamic driving task, achieves a reasonably safe state that may include
5 bringing the automated vehicle to a complete stop.

6 (8) “Operational design domain” means a description of the specific
7 domain or domains in which an automated driving system is designed to
8 properly operate, including types of roadways, ranges of speed, weather, time
9 of day, and environmental conditions.

10 (9) “Operator” means an individual employed by or under contract with
11 an automated vehicle tester who has successfully completed the tester’s
12 training on safe driving and the capabilities and limitations of the automated
13 vehicle and automated driving system, can take immediate manual or remote
14 control of the automated vehicle being tested, is 21 years of age or greater, and
15 holds an operator’s license for the class of vehicle being tested.

16 (10) “Public highway” means a State or municipal highway as defined
17 in 19 V.S.A. § 1(12).

18 (11) “SAE J3016” means the document published by SAE International
19 on September 30, 2016 as “Taxonomy and Definitions for Terms Related to
20 Driving Automation Systems for On-Road Motor Vehicles” and any
21 subsequent versions.

1 § 4203. TESTING OF AUTOMATED VEHICLES ON PUBLIC

2 HIGHWAYS

3 (a) An automated vehicle shall not be operated on public highways for
4 testing until the Traffic Committee as defined in 19 V.S.A. § 1(24) approves a
5 permit application for automated vehicle testers that defines the scope and
6 operational design domain for the test and demonstrates the ability of the
7 automated vehicle tester to comply with the requirements of this section.

8 (b) Prior to approving a permit application, the Traffic Committee will
9 conduct a hearing to provide for comments from the public.

10 (c) A person aggrieved by a decision of the Traffic Committee regarding an
11 automated vehicle test permit may appeal to the Civil Division of the Superior
12 Court of Washington County under Rule 74 of the Vermont Rules of Civil
13 Procedure.

14 (d) Before a test commences, the automated vehicle tester shall make
15 approved automated vehicle test permits readily available to law enforcement
16 and municipalities within the operational design domain designated in the
17 permit.

18 (e) Following completion of an automated vehicle test, the automated
19 vehicle tester shall submit a report to the Traffic Committee summarizing
20 results and observations related to safety, traffic operations, interaction with

1 roadway infrastructure, comments from the public, and any other relevant
2 matters.

3 (f) An automated vehicle tester shall not test an automated vehicle on a
4 public highway unless:

5 (1) The operator is:

6 (A) seated in the driver’s seat of the automated vehicle;

7 (B) monitoring the operation of the automated vehicle; and

8 (C) capable of taking immediate manual control of such automated
9 vehicle.

10 (2) The automated vehicle tester:

11 (A) registers each automated vehicle to be tested with the
12 Commissioner pursuant to chapter 7 of this title;

13 (B) submits to the Commissioner, in a manner and form directed by
14 the Commissioner, proof of liability insurance, self-insurance, or a surety bond
15 of at least five million dollars for damages by reason of bodily injury, death, or
16 property damage caused by an automated vehicle while engaged in automated
17 vehicle testing;

18 (C) has established and enforces a zero-tolerance policy for drug and
19 alcohol use by operators while engaged in automated vehicle testing. The
20 policy shall include provisions for investigations of alleged policy violations
21 and the suspension of drivers under investigation;

1 (D) has conducted background checks for all operators pursuant to
2 section 751 of this title, which may be inspected by the Commissioner of
3 Motor Vehicles or designee pursuant to section 752 of this title; and

4 (E) has certified that the legislative bodies of the municipalities
5 where an automated vehicle will be tested have approved the operational
6 design domain for class 1, 2, 3, or 4 town highways as classified pursuant to 19
7 V.S.A. § 302 included in the test.

8 (3) The operator and automated vehicle tester shall:

9 (A) comply with standards established by the National Highway
10 Traffic Safety Administration regarding automated vehicles and be capable of
11 providing proof of exemptions or waivers to such standards;

12 (B) report to the Agency of Transportation and the applicable law
13 enforcement agency within 10 business days after any motor vehicle crash
14 involving the testing of the automated vehicle that results in personal injury or
15 property damage; and

16 (C) satisfy any other requirements and permit conditions as
17 determined by the Traffic Committee as necessary to ensure the safe operation
18 of such automated vehicles.

19 (g) Notwithstanding subsection (f) of this section, a highly automated
20 vehicle may be tested on a public highway without an operator inside the
21 vehicle if the operator or automated vehicle tester can take immediate remote

1 control of the highly automated vehicle being tested and the vehicle can
2 achieve a minimal risk condition.

3 (h) An automated vehicle testing permit may be voided and invalidated for
