


\*NHTSA Totals include the \$ 1.7M carry forward and the \$2.4M new Comprehensive Distracted Driving funds that were not originally programed in the FFY20 Highway Safety Plan.



\*The amount budgeted does not reflect the amount expended.







\*In FFY20 the State received \$2.4M in Comprehensive Distracted Driving funds 405 (e). This the first time the State has been eligible for these funds.

\*In FFY19 and 20 the State received \$375,000 in Racial Profiling Data Collection 1906 funding. The maximum the State can receive this funding is two years.

\*In FFY20 the SHSO had to estimate the State and Community Highway Safety section 402 funds at FFY19 levels due to NHTSA not releasing the funding amount to the State.

\*In FFY20 the State did not receive the Non-Motorized 405(h) funds. In FFY19 \$215,716 was received because if the annual combined pedestrian and bicyclist fatalities in the state exceed 15 percent of the total annual crash fatalities in the State using the most recently available final data from NHTSA's FARS.
