## Sunset Advisory Commission Board and Commission Review

The Commission reviews every State board and commission and takes testimony regarding whether each board or commission should continue to operate or be eliminated and whether the powers and duties of any board or commission should be revised. Each board and commission has the burden of justifying its continued operation.

The Commission also reviews whether members of a board or commission should be entitled to a per diem and, if so, the amount of that per diem.

In testifying before the Commission, you should be able to provide the following information:

- 1. In general, how often does the board and commission meet? Provide specific information on how often the board or commission has met in the past two fiscal years. Provide information on where agendas and minutes of meetings can be found.
  - a. The Board meets quarterly but can meet more if needed.
  - b. Agendas and minutes are distributed internally to members and are maintained by the Board's co-chairs. These minutes are reported federally every June.
- 2. Provide the names of members of the board or commission, their term length and expiration, their appointing authority, and the amount of any per diem they receive.
  - a. Terms are two-years but there is no term limit; there is no per diem. The appointing authority is the DCF Commissioner.
  - b. Members: See attached.
- 3. Provide an overview of the board or commission's purpose.
  - a. The Vermont Citizen's Advisory Board (VCAB) is a citizen review panel which must be in existence in order for the state to receive federal Child Abuse Prevention and Treatment Act (CAPTA) funds. This board is empaneled as a child protection team pursuant to 33 VSA Chpt 49.
  - b. VCAB examines policies, practices and procedures of the state's child protection agency and where appropriate, reviews specific cases to evaluate the extent to which the agency is discharging its responsibilities. The board fosters communication and cooperation among professionals and organizations throughout Vermont and provides public informational and educational services about the identification, treatment and prevention of child abuse and neglect.
- 4. Is that purpose still needed? What would happen if the board or commission no longer fulfilled that purpose?
  - a. Yes, this is still needed. It is a requirement of the federal CAPTA act.

- b. Without this Board, the state may face severe negative fiscal implications/sanctions from the federal government.
- 5. How well is the board or commission performing in executing that purpose? What evidence can you provide to substantiate that performance?
  - a. Yes, the board is executing its purpose through their quarterly meetings and federal report. They also helped establish the current Mandated Reporter online training, they review cases regularly and examine policy.
- 6. If the purpose is still needed, can State government be more effective and efficient if the purpose was executed in a different manner?
  - a. We do not believe there is another way to execute the functions of this board in line with the federal level mandate for it to exist.
- 7. If the purpose is still needed, do any of your board or commission's functions overlap or duplicate those of another State board or commission or federal or State agency? If so, is your board or commission still the best entity to fulfill the purpose?
  - a. This board serves a particular purpose that fulfills a federal mandate. The Child Fatality Review Board reviews similar cases but with a different lens and they monitor all fatalities, not just those derived from abuse and neglect. The VCAB monitors these events with a child welfare system lens.
- 8. Does the board or commission's enabling law continue to correctly reflect the purpose and activities of the board or commission?
  - a. Yes
- 9. Provide a list of the board and commission's last fiscal year expenditures including staffing costs. How are these funded?
  - a. \$40.75 for FY19 coffee expense for the year. The DCF Commissioner's Office budget pays for this.
- 10. Is the board or commission required by law to prepare any reports or studies for the Legislature, the Governor, or any State agency or officer? If so, have those reports or studies been produced? Does the board or commission have ongoing reporting obligations?
  - a. The Board provides their quarterly minutes for the Family Services Division annual federal report.
  - b. Governor Shumlin also requested a special review and report following the toddler fatalities in 2014.
- 11. How would you measure the performance of the board or commission?
  - a. Their success is measured by their mandate to meet quarterly, examine Family Services policies, and review cases of child abuse and neglect.
