5 Subject: Public safety; fireworks

6 Statement of purpose of bill as introduced: This bill proposes to require that a
7 purchaser of fireworks present his or her permit for fireworks use to the seller
8 at the time of the sale, and prohibits the use of fireworks after 10:00 p.m.

9 An act relating to the sale and use of fireworks

10 It is hereby enacted by the General Assembly of the State of Vermont:

11 Sec. 1. 20 V.S.A. § 3132 is amended to read:

12 § 3132. PROHIBITIONS; PERMITS

13 (a) Except as provided in this section, it shall be unlawful for any person,
14 firm, co-partnership, or corporation to do any of the following:

15 (1) ~~Offer~~ offer for sale, expose for sale, sell at retail or wholesale, or
16 possess fireworks unless the person has been issued a permit by both the U.S.
17 Bureau of Alcohol, Tobacco, and Firearms and the municipality in which the
18 person offers for sale and stores the fireworks;

1 (2) ~~Use, possess, use~~ or explode any fireworks unless the person has
2 been issued a permit to display fireworks pursuant to subsection (c) of this
3 section;

4 (3) ~~Transport fireworks except in interstate commerce.~~ [Repealed.]

5 (4) ~~Offer~~ offer for sale or sell ~~hand-held~~ handheld sparklers as described
6 in subdivision 3131(1) of this title to a minor;

7 (5) ~~Offer~~ offer for sale or sell sparklers that are not in compliance with
8 ~~the United States~~ U.S. Consumer Product Safety Commission regulations.

9 (b) The ~~state fire marshal~~ State Fire Marshal shall have power to adopt
10 reasonable rules ~~and regulations~~ for granting permits for supervised public
11 displays of fireworks by municipalities, fair associations, amusement parks,
12 and other organizations or groups of individuals.

13 (c) Any display for which a permit is issued shall be handled by a
14 competent operator to be approved by the chiefs of police and fire departments
15 of the municipality in which the display is to be held and shall be of a
16 character, and so located, discharged, or fired as, in the opinion of the chief of
17 the fire department, or in a municipality with no fire department, the
18 selectboard, after proper inspection, shall not be hazardous to property or
19 endanger any person or persons.

20 (d) Application for permits shall be made to the chief of the fire
21 department, or in municipalities with no fire department, the selectboard, in

1 writing, at least 15 days in advance of the date of the display. After the permit
2 has been granted, sales, ~~possessions~~, use, and distribution of fireworks for the
3 display shall be lawful for that purpose only. No permit granted under this
4 section shall be transferable.

5 (e) A person who sells fireworks at retail shall provide to the purchaser at
6 the time of sale information regarding:

7 (1) the requirement that a permit must be obtained for the use or
8 explosion of fireworks; and

9 (2) the purchaser's obligation to comply with any municipal ordinance
10 regulating use of fireworks.

11 (f)(1) No person shall explode fireworks between the hours of 10:00 p.m.
12 and 7:00 a.m.

13 (2) A person who violates subdivision (1) of this subsection shall be
14 assessed a civil penalty of not more than \$200.00.

15 (3) Subdivision (1) of this subsection shall not apply:

16 (A) on the following dates: July 3, July 4, December 31, and
17 January 1;

18 (B) to uses permitted by section 3133 of this title; or

19 (C) if the use is permitted by a municipal ordinance.
