10	Statement of purpose of bill as introduced: This bill proposes to prohibit an
11	inmate from earning a sentence reduction for good time if the inmate is serving
12	a sentence for an offense that caused death or serious bodily injury.
13 14	An act relating to prohibiting good time sentence reductions for offenses that cause death or serious bodily injury
15	It is hereby enacted by the General Assembly of the State of Vermont:
16	Sec. 1. 28 V.S.A. § 818 is amended to read:
17	§ 818. EARNED GOOD TIME; REDUCTION OF TERM
18	(a) On or before September 1, 2020, the Department of Corrections shall
19	file a proposed rule pursuant to 3 V.S.A. chapter 25 implementing an earned
20	good time program to become effective on January 1, 2021. The

1	Commissioner shall adopt rules to carry out the provisions of this section as an
2	emergency rule and concurrently propose them as a permanent rule. The
3	emergency rule shall be deemed to meet the standard for the adoption of
4	emergency rules pursuant to 3 V.S.A. § 844(a).
5	(b) The earned good time program implemented pursuant to this section
6	shall comply with the following standards:
7	(1) The program shall be available for all sentenced offenders, including
8	furloughed offenders, provided that the program shall not be available to
9	offenders on probation or parole, to offenders eligible for a reduction of term
10	pursuant to section 811 of this title, to offenders sentenced for an offense that
11	resulted in death or serious bodily injury, or to offenders sentenced to life
12	without parole. Offenders currently serving a sentence shall be eligible to
13	begin earning a reduction in term when the earned good time program becomes
14	effective.
15	(2) Offenders shall earn a reduction of seven days in the minimum and
16	maximum sentence for each month during which the offender:
17	(A) is not adjudicated of a major disciplinary rule violation; and
18	(B) is not reincarcerated from the community for a violation of
19	release conditions, provided that an offender who loses a residence for a reason

other than fault on the part of the offender shall not be deemed reincarcerated
under this subdivision.
