17	§ 312. RIGHT TO ATTEND MEETINGS OF PUBLIC AGENCIES
18	(a)(1) All meetings of a public body are declared to be open to the public at
19	all times, except as provided in section 313 of this title. No resolution, rule,
20	regulation, appointment, or formal action shall be considered binding except as

1	taken or made at such open meeting, except as provided under subdivision
2	313(a)(2) of this title. A meeting of a public body is subject to the public
3	accommodation requirements of 9 V.S.A. chapter 139. A public body shall
4	electronically record all public hearings held to provide a forum for public
5	comment on a proposed rule, pursuant to 3 V.S.A. § 840. The public shall
6	have access to copies of such electronic recordings as described in section 316
7	of this title.

9	(3) Simultaneous broadcast via electronic means. A public body shall
10	simultaneously broadcast via electronic means any meeting of the public body
11	The public body shall publish the publicly accessible location of the
12	simultaneous broadcast in the warning and agenda for each meeting. The
13	public body shall begin the simultaneous broadcast at the time that the first
14	member of the public body arrives for the meeting.

17	§ 313. EXECUTIVE SESSIONS
18	(a) No public body may hold an executive session from which the public is
19	excluded, except by the affirmative vote of two-thirds of its members present

in the case of any public body of State government or of a majority of its

members present in the case of any public body of a municipality or other

political subdivision. A motion to go into executive session shall indicate the
nature of the business of the executive session, and no other matter may be
considered in the executive session. Such The vote shall be taken in the course
of an open meeting and the result of the vote recorded in the minutes. No
formal or binding action shall be taken in executive session except for actions
relating to the securing of real estate options under subdivision (2) of this
subsection. Minutes of an executive session need not be taken, but if they are,
the minutes shall, notwithstanding subsection 312(b) of this title, be exempt
from public copying and inspection under the Public Records Act. A public
body shall record audio and video of any executive session held pursuant to
this section. A recording of an executive session shall be exempt from public
inspection and copying under the Public Records Act, except in instances
where the basis for the confidentiality of the executive session is no longer
applicable. A public body may not hold an executive session except to
consider one or more of the following:
