8	Subject: Health; mental health; peer support specialists; certification
9	Statement of purpose of bill as introduced: This bill proposes to establish a
10	mental health peer support specialist certification program.
11	An act relating to the certification of mental health peer support specialists
12	It is hereby enacted by the General Assembly of the State of Vermont:
13	Sec. 1. FINDINGS
14	The General Assembly finds that:
15	(1) The Centers for Medicare and Medicaid Services (CMS) recognizes
16	that the experiences of peer support specialists, as part of an evidence-based
17	model of care, can be an important component in a state's delivery of effective
18	mental health treatment. CMS encourages states to offer comprehensive
19	programs.

1	(2) Research studies have demonstrated that peer supports improve an
2	individual's functioning, increase an individual's satisfaction, alleviate
3	symptoms, reduce hospitalizations and hospital days, increase an individual's
4	satisfaction with treatment, and enhance an individual's self-advocacy.
5	(3) Certification can encourage an increase in the number, diversity, and
6	availability of peer support specialists.
7	(4) The U.S. Department of Veterans Affairs, more than 46 states, and
8	the District of Columbia have created statewide mental health peer certification
9	programs.
10	(5) Mental health peers in Vermont are currently providing
11	individualized support, coaching facilitation, and education to individuals with
12	mental health needs, in a variety of settings, yet no statewide scope of practice,
13	standardized curriculum, training standards, supervision standards, or
14	certification protocols are available.
15	Sec. 2. 18 V.S.A. chapter 176 is added to read:
16	CHAPTER 176. PEER SUPPORT SPECIALISTS
17	<u>§ 7351. PURPOSE</u>
18	It is the intent of the General Assembly that the peer support specialist
19	certification program established in this chapter achieve the following:

1	(1) support the ongoing provision of services by certified peer support
2	specialists for individuals experiencing a mental condition or substance use
3	disorder, or both;
4	(2) support coaching, skill building, and fostering social connections
5	among individuals experiencing a mental condition or substance use disorder,
6	or both;
7	(3) provide one part in a continuum of services, in conjunction with
8	other community mental health and recovery services;
9	(4) collaborate with others providing care or support to an individual
10	experiencing a mental condition or substance use disorder, or both;
11	(5) assist individuals experiencing a mental condition or substance use
12	disorder, or both, in developing coping mechanisms and problem-solving
13	<u>skills;</u>
14	(6) promote skill building for individuals with regard to socialization,
15	recovery, self-sufficiency, self-advocacy, development of natural supports, and
16	maintenance of skills learned in other support services; and
17	(7) encourage employment of peer support specialists.
18	§ 7352. DEFINITIONS
19	As used in this chapter:
20	(1) "Agency" means the Agency of Human Services.

1	(2) "Certification" means the activities of the certifying body related to
2	the verification that an individual has met all the requirements under this
3	chapter and that the individual may provide mental health and substance use
4	disorder treatment pursuant to this chapter.
5	(3) "Certified" means all federal and State requirements have been
6	satisfied by an individual who is seeking designation pursuant to this chapter,
7	including completion of curriculum and training requirements, testing, and
8	agreement to uphold and abide by the code of ethics.
9	(4) "Code of ethics" means the standards to which a peer support
10	specialist is required to adhere.
11	(5) "Collaborative documentation" means a model in which peer support
12	specialists and recipients of peer support services collaborate in periodically
13	creating intake and assessment summaries, service plans, progress notes, or
14	tallies of services rendered, or any combination of these tasks. Collaborative
15	documentation may be completed at weekly or monthly intervals rather than at
16	every encounter.
17	(6) "Core competencies" means the foundational and essential
18	knowledge, skills, and abilities required for peer specialists.
19	(7) "Peer-run" means an entity, program, or service that is controlled
20	and operated by individuals with lived experience of the mental health system,
21	a mental health condition, or substance use disorder.

1	(8) "Peer support" means an approach to relationships that recognizes
2	each individual as the expert of the individual's own experience, fosters
3	connection through shared or similar experiences, centers mutuality and
4	mutual support, preserves autonomy, and creates opportunity for meaningful
5	connections and exploring possibilities.
6	(9) "Peer support specialist" means an individual who is at least 18
7	years of age and who self-identifies as having lived experience with the
8	process of recovery from a mental health condition or substance use disorder,
9	or both, including the parent or family member of an individual who has such
10	lived experience and who has been granted certification pursuant to this
11	chapter.
12	(10) "Recovery" means a process of change through which individuals
13	improve their health and wellness, live a self-directed life, and strive to reach
14	their full potential. This process of change honors the different routes to
15	recovery based on the individual.
16	§ 7353. PEER SUPPORT SPECIALIST CERTIFICATION
17	(a) Program development.
18	(1) The Agency shall contract with a peer-run entity to develop a
19	statewide certification program for peer support specialists in accordance with
20	guidance issued by the Centers for Medicare and Medicaid Services' State

1	Medicaid Director Letter #07-011. The peer-run entity under contract pursuant
2	to this subsection shall:
3	(A) Define the range of responsibilities, practice guidelines, and
4	supervision standards for peer support specialists using leading practice
5	materials and the opinions of peer experts in the field.
6	(B) Determine the curriculum and core competencies required for
7	certification as a peer support specialist, including curriculum that may be
8	offered in areas of specialization, such as veterans affairs, gender identity,
9	sexual orientation, and any other area of specialization recognized by the
10	certifying body. The core competencies curriculum shall include, at a
11	minimum, training related to the following elements;
12	(i) peer support values and orientation, including authentic and
13	mutual relationships;
14	(ii) lived experience;
15	(iii) the concepts of resilience, recovery, and wellness;
16	(iv) self-determination;
17	(v) trauma-informed practice;
18	(vi) human rights-based approach and advocacy;
19	(vii) cultural competence;
20	(viii) group facilitation skills, including communication, dialogue,
21	and active listening;

1	(ix) self-awareness and self-care;
2	(x) conflict resolution;
3	(xi) professional boundaries and ethics;
4	(xii) collaborative documentation skills and standards; and
5	(xiii) confidentiality.
6	(C) Establish a code of ethics for peer support specialists.
7	(D) Determine the process and continuing education requirements for
8	biennial certification renewal.
9	(E) Determine the process for investigating complaints and taking
10	corrective action, which may include suspension and revocation of
11	certification.
12	(F) Determine a process for an individual employed as a peer support
13	specialist on and after December 31, 2021 to obtain a certification pursuant to
14	this chapter, which shall include, at a minimum, a passing certification
15	examination specifically created for this purpose.
16	(2) In developing a statewide certification program for peer support
17	specialists pursuant to this subsection, the peer-run entity under contract with
18	the Agency shall seek feedback and recommendations from mental health
19	peer-run and family organizations, hospitals, and mental health and substance
20	use disorder treatment providers and organizations by convening not fewer
21	than four stakeholder meetings.

1	(b) Screening and training. The Agency shall contract with a peer-run
2	entity to screen and train prospective peer support specialists consistent with
3	the curriculum and core competencies developed pursuant to subsection (a) of
4	this section.
5	(c) Certification. The Agency shall contract with a peer-run entity to serve
6	as the certifying entity for mental health peer support specialists. This peer-run
7	entity shall:
8	(1) determine whether an applicant has met the requirements for
9	certification established pursuant to subsection (a) of this section through the
10	administration of an examination; and
11	(2) adhere to the processes for certification, recertification, certification
12	revocation, and appeals established pursuant to subsection (a) of this section.
13	(d) Exemption. Individuals providing peer support services as employees
14	or volunteers of a peer-run organization shall not be required to obtain peer
15	support specialist certification.
16	§ 7354. APPLICANTS FOR CERTIFICATION
17	(a) An applicant for certification pursuant to this chapter shall:
18	(1) be at least 18 years of age;
19	(2) be self-identified as having first-hand experience with the process of
20	recovery from mental illness or substance use disorder treatment or be the
21	family member of such an individual;

1	(3) be willing to share personal experiences;
2	(4) agree, in writing, to the code of ethics developed pursuant to section
3	7353 of this title;
4	(5) successfully complete the curriculum and training requirements for
5	peer support specialists; and
6	(6) pass a certification examination approved by the certifying body for
7	peer support specialists.
8	(b) To maintain certification pursuant to this act, a peer support specialist
9	<u>shall:</u>
10	(1) adhere to the code of ethics developed pursuant to section 7353 of
11	this title and sign a biennial affirmation to that effect; and
12	(2) complete any required continuing education, training, and
13	recertification requirements developed by the certifying body.
14	§ 7355. CERTIFICATION FEE SCHEDULE
15	Any fees required for the administration of the peer support specialist
16	certification program set forth in this chapter shall be requested pursuant to the
17	process set forth in 32 V.S.A. chapter 7, subchapter 6.
18	Sec. 3. MEDICAID; STATE PLAN AMENDMENT
19	(a) The Agency of Human Services shall seek approval from the Centers
20	for Medicare and Medicaid Services to amend Vermont's Medicaid state plan
21	to do the following:

1	(1) include a certified peer support specialist pursuant to 18 V.S.A.
2	chapter 176 as a provider type;
3	(2) include peer support specialist services as a Medicaid covered
4	service;
5	(3) allow beneficiaries to self-refer for peer support specialist services;
6	(4) allow for collaborative documentation of peer support specialist
7	services; and
8	(5) allow reimbursement for peer support specialist services for a range
9	of Healthcare Common Procedure Coding System codes, including the
10	following:
11	(A) H0038: Self-help/peer services;
12	(B) G0177: Training and educational services related to the care and
13	treatment of a patient's disabling mental health problem;
14	(C) H0023: Behavioral health outreach service;
15	(D) H2014: Skills training and development;
16	(E) H2015: Community support;
17	(F) H2017: Psychiatric rehabilitation;
18	(G) H2019: Therapeutic behavioral services;
19	(H) H2021: Community-based wraparound;
20	(I) H2023: Supported employment/supported education;
21	(J) H2027: Psychoeducational services; and

1	(K) T1016: Case management.
2	(b) As used in this section:
3	(1) "Collaborative documentation" means a model in which peer support
4	specialists and recipients of peer support services collaborate in periodically
5	creating intake and assessment summaries, service plans, progress notes, or
6	tallies of services rendered, or any combination of these tasks. Collaborative
7	documentation may be completed at weekly or monthly intervals rather than at
8	every encounter.
9	(2) "Peer support specialist services" means services provided by a peer
10	support specialist as defined in 18 V.S.A. chapter 176 that promote
11	engagement, socialization, recovery, self-sufficiency, self-advocacy,
12	development of natural supports, identification of strengths, and maintenance
13	of skills learned in other support services.

15	§ 1901k. MEDICAID REIMBURSEMENT FOR PEER SUPPORT
16	SPECIALIST SERVICES
17	(a) As used in this section, "peer support specialist services" means
18	services provided by a peer support specialist as defined in 18 V.S.A.
19	chapter 176 that promote engagement, socialization, recovery, self-sufficiency,
20	self-advocacy, development of natural supports, identification of strengths, and
21	maintenance of skills learned in other support services.

1	(b) The Department of Vermont Health Access shall reimburse peer
2	support specialists in accordance with Vermont's Medicaid state plan.
3	Sec. 5. APPROPRIATION
4	In fiscal year 2023, \$525,000.00 is appropriated to the Agency of Human
5	Services from the General Fund for the development and operation of the peer
6	support specialist certification program pursuant to 18 V.S.A. chapter 176.
7	The Agency shall seek to maximize federal financial participation in funding
8	these administrative costs.
9	Sec. 6. EFFECTIVE DATES
10	This act shall take effect on July 1, 2022, except that Sec. 4 (Medicaid
11	reimbursement for peer support specialist services) shall take effect upon
12	approval of the Medicaid state plan amendment in Sec. 3 by the Centers for
13	Medicare and Medicaid Services.
