6 Statement of purpose of bill as introduced: This bill proposes to approve the

7 amendments to the charter of the Town of Hardwick to:

8 (1) merge the town offices of Town Clerk and Town Treasurer into the

9 Town Clerk and Treasurer;

10 (2) rename the Zoning Board of Adjustment the Development Review

11 Board;

12 (3) require digital notice of all regular and special town meetings;

13 (4) eliminate some town offices; and

14 (5) make clerical edits.

15 An act relating to amending the charter of the Town of Hardwick

16 It is hereby enacted by the General Assembly of the State of Vermont:

17 Sec. 1. CHARTER AMENDMENT APPROVAL

1 The General Assembly approves the amendments to the charter of the Town
2 of Hardwick as set forth in this act. The voters approved the proposals of
3 amendment on December 9, 2021.

4 Sec. 2. 24 App. V.S.A. chapter 123 is amended to read:

6 Subchapter 1. Incorporation ~~And~~ and Grant ~~Of~~ of Powers

7 § 101. CORPORATE EXISTENCE RETAINED

8 The inhabitants of the Town of Hardwick as presently constituted ~~and the~~
9 ~~inhabitants of the Village of Hardwick as constituted by 1890 Acts and~~
10 ~~Resolves No. 84, as amended by 1892 Acts and Resolves No. 6, 1892 Acts and~~

8 § 105. RESERVATION OF POWERS TO THE TOWN

9 Nothing in this charter shall be construed to in any way limit the powers
10 and functions conferred on the Town of Hardwick, ~~the~~ its Selectboard of said
11 ~~Town~~, or its elected and appointed officials by general or special enactments of
12 State statutes or regulations in force or effect or ~~hereafter~~ enacted after
13 adoption of this charter, and the powers and functions conferred by this charter
14 shall by this charter be cumulative and in addition to the provisions of ~~such~~
15 general enactments unless this charter otherwise provides.

17 § 107. ORDINANCES; ADOPTION BY THE SELECTBOARD

18 (a) If the Selectboard desires to adopt an ordinance, ~~they~~ the Selectboard
19 shall ~~cause it to be entered~~ record it in the official record kept of ~~their~~ the
20 Selectboard proceedings, and ~~thereafter, they~~ the Selectboard shall adopt it
21 subject to final approval after the public hearing as ~~hereafter~~ set forth in this

1 section. The ordinance shall then be posted in three public places within the
2 Town and published by title and summary setting forth the subject matter,
3 effective date, and penalty for violation ~~thereof~~ of the ordinance in a
4 newspaper of general circulation in the Town, together with a notice of the
5 time and place of a public hearing to consider the ordinance for final passage,
6 ~~such~~ the publication and posting to be on a day at least one week and not more
7 than two weeks prior to the hearing.

(c) After the public hearing, the Selectboard may finally adopt the ordinance, with or without amendment. ~~If it the Board amends the ordinance prior to passage, it the Board shall cause the amended ordinance~~ *If it the Selectboard amends the ordinance prior to passage, it the Selectboard shall cause the amended ordinance* to be entered in the official record of its proceedings, and shall also cause notice of the amended and passed ordinance to be published in a newspaper of general circulation in the Town on a day not more than 14 days after adoption.

10 § 110. ~~NONAPPLICABILITY~~ NON-APPLICABILITY OF ZONING AND
11 SUBDIVISION

12 The provisions of sections 107, 108, and 109 of this charter shall not apply
13 to the enactment, amendment, or repeal of any zoning ordinance or bylaw, any

1 land subdivision ordinance or land subdivision bylaw, nor to the enactment,
2 amendment, or repeal of any municipal plan, or comprehensive regional plan,
3 the enactment, amendment, or repeal of such zoning ordinances, bylaws, and
4 plans being specifically controlled by 24 V.S.A. chapter 117, or by such other
5 statute regulating zoning, subdivision, and municipal and regional plans as
6 may be enacted from time to time. The adoption, amendment, or repeal of all
7 other ordinances shall be in conformity with sections 107, 108, and 109 of this
8 charter.

10 § 112. AUTHORITY OF POLICE OFFICERS

11 ~~The police~~ Police officers of the Town shall have those powers conferred
12 upon them by 24 V.S.A. chapter 55 and by all other laws applicable to
13 municipal police officers.

14 § 113. OPEN MEETINGS

15 Meetings of all Town boards ~~and commissions shall be open and held in~~
16 ~~accordance with the general law of this State relating to public meetings. The~~
17 ~~record of all official proceedings shall be available for public inspection and~~
18 ~~copying as provided by the general law of this State, commissions, and formal~~
19 ~~committees shall conform with the provisions of 1 V.S.A. §§ 310–314 of~~

1 The municipal government provided by this charter shall be known as the

 4 this charter, all powers of the Town shall be vested in an elective Council,
 5 which shall be known as the Selectboard ~~n~~, which shall enact ordinances,

 7 Town Manager, who shall execute the laws and administer the government of

14 § 307. VACANCIES AND APPOINTMENTS

15 (a) When the term of any member of the ~~Zoning~~ Development Review
16 ~~Board of Adjustment~~, the Planning Commission, or any other Town board or,
17 commission, or formal committee expires, or when the term of any officer
18 appointed by the Selectboard or the Town Manager expires, or when there is a
19 vacancy in any ~~such~~ board, commission, committee, or office, the Town
20 Manager may cause to be published, in a newspaper or digital news forum of

1 general local circulation or availability, and on the Town website, a notice of
2 the vacancy or the expiration of the term.

3 (b) Any qualified voter of the Town may, within 10 days of the
4 publication, may submit ~~his or her~~ their own name to the Town Manager as an
5 applicant for the vacant or expired office. At the expiration or 10 days from
6 the date of publication, the names of all persons being considered shall be
7 entered in the Selectboard minutes. The Selectboard shall not fill the vacancy
8 or expired term until after at least seven days from the date the names of the
9 applicants are entered in the minutes.

All elective officials and all municipal police officers of the Town shall,
before assuming office, take, subscribe, and file with the Town Clerk and
Treasurer the following oath:

13 of _____ of the Town of Hardwick to the best of my judgment and abilities,
14 according to law, so help me God (or I so affirm).”

5 (a) ~~Forthwith after their~~ After the election and qualification of the
6 Selectboard, the Selectboard shall organize and elect a Chair and Vice Chair by
7 a majority vote of the entire Board.

9 Robert's Rules of Order. The Chair shall be entitled to participate as a full

§ 903. SEWAGE COLLECTION AND DISPOSAL; DUTIES OF
SELECTBOARD

It shall be the responsibility of the Selectboard, acting as sewer commissioners, to provide adequate collection and disposal for domestic and industrial ~~sewerage~~ sewage within those parts of the Town served by ~~existing a~~ Town-owned sewage collection and distribution system. In order to implement ~~said~~ the authority, the Selectboard shall have, in addition to those powers enumerated in the general laws of this State with respect to sewage disposal, the following powers:

(1) Whenever the public health or convenience shall require the construction of a common sewer or sewers in the Town, the Selectboard is ~~hereby~~ authorized and empowered to ~~so~~ construct ~~said~~ sewers and to ~~repair~~ replace the same from time to time when necessary, and ~~for such purpose~~ may take the land of individuals and corporations on making compensation for the lands so taken for construction or replacement of a common sewer or sewers, and the Selectboard shall proceed in the same manner as is prescribed by law for selectboards in taking for public highways and in awarding damages ~~therefore~~ for the taking of land, and the ~~said Selectboard~~ Selectboard shall make a return of their doings to the office of the Town Clerk ~~of said Town~~ and Treasurer who shall record the same in the Town records ~~of the Town~~, and ~~said~~

1 the Town may also lay pipes along and across the streets, alleys, lanes, and
2 highways in ~~said Town~~ Hardwick.

3 (2) The Selectboard shall have the power by ordinance and regulations
4 to require any building owner to connect to and use any sewer drain or line
5 installed and maintained along and across the streets, alleys, lanes, and
6 highways of the Town that abut or adjoin ~~such~~ that building.

7 (3) ~~Said~~ The Selectboard, in making, installing, maintaining, or
8 repairing sewers and drains, shall have the power, on giving 12 days' notice to
9 the parties interested of the time and the place of hearing, to assess the owner
10 or owners of land or lands benefited ~~thereby~~ by access to sewers and drains, so
11 much of the expense of making altering or repairing the same as ~~said~~ the
12 Selectboard shall judge ~~such~~ those lands to be benefited ~~thereby~~ by access to
13 sewers and drains.

14 (4) When ~~said~~ the Selectboard enters upon lands under the authority and
15 for the purpose stated in subdivision (3) of this section, ~~they~~ the Selectboard
16 shall give 12 days' notice to all persons owning or interested in ~~such~~ those
17 lands when ~~they~~ the Selectboard will hear and consider the question of
18 assessments for benefits, or both. And in all cases when either assessments are
19 made or damages are allowed, the ~~said~~ Selectboard shall ~~forthwith~~ make a
20 report of ~~their~~ the Selectboard's doings, which report ~~they~~ the Board shall

1 cause to be filed in the office of the Town Clerk and Treasurer, who shall
2 record the same in the Town records of said Town.

3 (5) When any person shall be dissatisfied with the decision of ~~said~~ the
4 Selectboard in the award of damages for laying, making, altering, or repairing
5 any sewer and drain, or in any assessment for benefits of the same, ~~sueh~~ those
6 persons may petition a court of competent jurisdiction for a reassessment of
7 ~~sueh~~ related damages or benefits. ~~Said~~ The petition shall be served on the
8 Town Clerk of said Town and Treasurer within 60 days ~~next~~ after said award
9 of damages or assessment for benefit shall be filed in ~~said Clerk's~~ the Town
10 Clerk and Treasurer's office, and ~~sueh~~ the petition shall not delay the making
11 or repairing of ~~sueh~~ the sewer or drain, or sidewalk or culvert, or laying ~~said~~
12 the water pipe.

1 shall serve for one year or until a successor is appointed and qualified. The
2 Zoning Administrator shall be nominated by the Planning Commission and
