5	Vermont, with particular attention shown to vulnerable populations, including:

7	(B) elders;
8	(C) persons with physical disabilities;
9	(D) persons with a chronic or existing medical condition;
10	(E) persons with low income;
11	(F) persons who are homeless or lack access to transportation;
12	(G) persons living in flood plains; and
13	(H) persons whose employment occurs primarily outdoors.
14	(2) The response plan shall provide actionable strategies specific to both

13	planning commissions shall be available for consultation and assistance
14	pursuant to 24 V.S.A. § 4345a. Needs identified through the process shall be
15	integrated with the hospital's long-term planning. Each hospital shall post on
16	its website a description of its identified needs, strategic initiatives developed
17	to address the identified needs, annual progress on implementation of the
18	proposed initiatives, opportunities for public participation, and the ways in
19	which the hospital ensures access to appropriate mental health care that meets
20	standards of quality, access, and affordability equivalent to other components
