11	health education, or health policy and to meet not less than twice per year;
12	require the Agency of Education to update and distribute to school districts a
13	model wellness program policy; and ensure that female students attending a
14	public school or an approved independent school have access to menstrual
15	hygiene products at no cost and without the embarrassment of having to
16	request them.

12	On or before January 15, 2022, the Agency of Education, in collaboration
13	with the Advisory Council on Wellness and Comprehensive Health created
14	under 16 V.S.A. § 136, shall update and distribute to school districts a model
15	wellness program policy, using the expanded definition of "wellness program"
16	under 16 V.S.A. § 136, as amended by this act, that shall:
17	(1) be in compliance with all relevant State and federal laws; and
18	(2) reflect nationally accepted best practices for comprehensive health
19	education and school wellness policies, such as guidance from the Centers for

2	§ 1432. MENSTRUAL HYGIENE PRODUCTS
3	(a) By enacting this statute, the General Assembly intends to ensure that a
4	female student attending a public school or an approved independent school
5	has access to menstrual hygiene products at no cost and without the
6	embarrassment of having to request them.
7	(b) A school district and an approved independent school shall make
8	menstrual hygiene products available at no cost in a majority of gender-neutral
9	bathrooms and bathrooms designated for females that are generally used by
10	females in any of grades five through 12 in each school within the district or
11	under the jurisdiction of the board of the independent school. The school
12	district or independent school, in consultation with the school nurse who
13	provides services to the school, shall determine which of the gender-neutral
14	bathrooms and bathrooms designated for females to stock with menstrual
15	hygiene products and which brands to use.
16	(c) School districts and approved independent schools shall bear the cost of
17	supplying menstrual hygiene products and may seek grants or partner with a

nonprofit or community-based organization to fulfill this obligation.
