4	underlying statutes, changes in health care delivery, changes in payment
5	methods and amounts, protecting insurer solvency, and other issues at the
6	discretion of the Board. The Board shall report to the General Assembly
7	within 15 calendar days following the Board's approval of any health
8	insurance rate at a level that represents an annual increase in excess of the
9	cumulative Consumer Price Index rate of inflation.
10	(7) Review and establish hospital budgets pursuant to chapter 221,
11	subchapter 7 of this title. The Board shall report to the General Assembly
12	within 15 calendar days following the Board's approval of any hospital's
