7	Statement of purpose of bill as introduced: This bill proposes to establish
8	statutory provisions that may be used for the operation of government in cases
9	of emergency.

10	An act relating to emergency provisions for the operation of government
11	It is hereby enacted by the General Assembly of the State of Vermont:
12	* * * Open Meeting Law * * *
13	Sec. 1. 1 V.S.A. § 312a is added to read:
14	§ 312a. MEETINGS OF PUBLIC BODIES; STATE OF EMERGENCY
15	(a) As used in this section:
16	(1) "Affected public body" means a public body:
17	(A) whose regular meeting location is located in an area affected by a
18	hazard; and
19	(B) that cannot meet in a designated physical meeting location due to
20	a declared state of emergency pursuant to 20 V.S.A. chapter 1.

1	(2) "Hazard" means an "all-hazards" as defined in 20 V.S.A. § 2(1).
2	(b) Notwithstanding subdivisions 312(a)(2)(D) and (c)(2) of this title,
3	during a declared state of emergency under 20 V.S.A. chapter 1:
4	(1) A quorum or more of an affected public body may attend a regular,
5	special, or emergency meeting by electronic or other means without
6	designating a physical meeting location where the public may attend.
7	(2) The members and staff of an affected public body shall not be
8	required to be physically present at a designated meeting location.
9	(3) An affected public body of a municipality may post any meeting
10	agenda or notice of a special meeting in two publicly accessible designated
11	electronic locations in lieu of the two designated public places in the
12	municipality, or in a combination of a designated electronic location and a
13	designated public place.
14	(c) When an affected public body meets electronically under subsection (b)
15	of this section, the affected public body shall:
16	(1) use technology that permits the attendance and participation of the
17	public through electronic or other means;
18	(2) whenever feasible, allow the public to access the meeting by
19	telephone; and

1	(3) post information that enables the public to directly access and
2	participate in meetings electronically and shall include this information in the
3	published agenda for each meeting.
4	(d) Unless unusual circumstances make it impossible for them to do so, the
5	legislative body of each municipality and each school board shall record any
6	meetings held pursuant to this section.
7	(e) An affected public body of a municipality shall continue to post notices
8	and agendas in or near the municipal clerk's office pursuant to
9	subdivision 312(c)(2) of this title and shall provide a copy of each notice or
10	agenda to the newspapers of general circulation for the municipality.

15	(c)(1) The Board board shall meet at the time and place so designated, and
16	on that day and from day to day thereafter shall hear and determine such
17	appeals until all questions and objections are heard and decided. Each
18	property, the appraisal of which is being appealed, shall be inspected by a
19	committee of not less than three members of the board who shall report to the
20	board within 30 days from the hearing on the appeal and before the final
21	decision pertaining to the property is given. If, after notice, the appellant

1	refuses to allow an inspection of the property as required under this subsection,
2	including the interior and exterior of any structure on the property, the appeal
3	shall be deemed withdrawn. The board shall, within 15 days from the time of
4	the report, certify in writing its notice of decision, with reasons, in the

1	(2) During a declared state of emergency under 20 V.S.A. chapter 1, a
2	board of civil authority within a municipality affected by an all-hazards event
3	shall not be required to physically inspect any property that is the subject of an
4	appeal. If the appellant requests in writing that the property be inspected for
5	purposes of the appeal, a member or members of the board shall conduct the
6	inspection through electronic means. If the appellant does not facilitate the
7	inspection through electronic means, then the appeal shall be deemed
8	withdrawn.
9	(3) As used in this subsection, "electronic means" means the transmittal
10	of video or photographic evidence by the appellant at the direction of the board
11	members conducting the inspection.
12	(d) Listers and agents to prosecute and defend suits wherein a town is
13	interested shall not be eligible to serve as members of the board while
14	convened to hear and determine such appeals nor shall an appellant, his or her
15	servant, agent, or attorney be eligible to serve as a member of the Board board
16	while convened to hear and determine any appeals. However, listers and
17	agents to prosecute and defend suits wherein a town is interested shall be given
18	the opportunity to defend the appraisals in question.

3	(a) Upon appeal to the Director or the Court court, the hearing officer or
4	Court court shall proceed de novo and determine the correct valuation of the

19	operation of that public water system; or a company engaged in the collecting,
20	sale, and distribution of water for domestic, industrial, business, or fire
21	protection purposes that is regulated by the Public Utility Commission under

1	30 V.S.A. § 203(3) shall be prohibited from disconnecting any person from
2	services during a declared state of emergency under 20 V.S.A. chapter 1,
3	provided that:
4	(1) the state of emergency is declared in response to an all-hazards event

18	(c) A ratepayer shall remain obligated for any amounts due to a water or
19	sewer service provider subject to this section. The ratepayer shall have a

4	FUNDING OF EMERGENCY SHERIFF NEEDS
5	(a) Funding.
6	(1)(A) During a state of emergency declared under 20 V.S.A. chapter 1
7	that affects a county, in order to support the emergency needs of that county's
8	sheriff due to that emergency, the county's operations reserve funds and capital
9	reserve funds described in subsection 133(e) of this chapter may be allowed to
10	be used for the emergency needs of the sheriff subject to the approval of the
11	assistant judges.
12	(B) As used in this section, "emergency needs" means the needs to
13	respond to the emergency and includes hiring deputies, dispatchers, and other
14	personnel and purchasing equipment and supplies.
15	(2) The funding of these emergency needs under this subsection shall be
16	in addition to the support of the sheriff's department set forth in section 73 of
17	this title.
18	(b) Reimbursement.
19	(1) Any sheriff who receives county reserve funds for emergency needs
20	under subsection (a) of this section shall apply to any applicable resources for

1	emergency relief, such as the Federal Emergency Management Agency
2	(FEMA), that are known to the sheriff for any allowable reimbursement.
3	(2) Within 30 days of receiving any such allowable reimbursement, the
4	sheriff shall provide those funds to the county in order to reimburse the county
5	for the funds allocated to the sheriff under subsection (a) of this section. A
6	sheriff shall only be responsible for reimbursing the county an amount equal to
7	the allowable reimbursement the sheriff received under subdivision (1) of this
8	subsection.
9	(c) Sunset. The authority for a sheriff to obtain funding for emergency
10	needs under subsection (a) of this section shall sunset two weeks after the day
11	the Governor terminates the state of emergency.

14	This act shall take effect on passage, except that Sec. 6 (repeal of 19 V.S.A.
15	<u>§ 312 (use of town highway funds)) shall take effect on July 1, 2021.</u>
