7	Statement of purpose of bill as introduced: This bill proposes to permit

19	(a) Notwithstanding any provision of 21 V.S.A. chapter 17 to the contrary,
20	an individual shall be eligible to receive or to continue to receive Pandemic

1	Emergency Unemployment Compensation benefits in lieu of regular
2	unemployment insurance benefits if:
3	(1) the individual was determined to be eligible for Pandemic
4	Emergency Unemployment Compensation during a benefit year that expired
5	after December 27, 2020;
6	(2) the individual has remaining entitlement to Pandemic Emergency
7	Unemployment Compensation benefits with respect to the expired benefit year;
8	(3) the individual would qualify pursuant to 21 V.S.A. chapter 17 for
9	regular unemployment insurance benefits in a new benefit year; and
10	(4) the weekly benefit amount for regular unemployment insurance
11	benefits in the new benefit year would be at least \$25.00 less than the weekly
12	benefit amount payable on the individual's Pandemic Emergency
13	Unemployment Compensation claim in the prior benefit year.
14	(b)(1) The new benefit year of an individual who is determined to be
15	eligible to receive or to continue receiving Pandemic Emergency
16	Unemployment Compensation benefits pursuant to subsection (a) of this
17	section shall not begin until after the individual has exhausted his or her
18	eligibility for Pandemic Emergency Unemployment Compensation benefits.
19	(2) The individual's weekly benefit amount for the new benefit year
20	shall be determined based on the wages that would have been in the

- deferred pursuant to this section. 2

- Notwithstanding 1 V.S.A. § 214, this act shall take effect retroactively on 4
