17	Sec. 1. CONTINUED ELIGIBILITY FOR PANDEMIC EMERGENCY
18	UNEMPLOYMENT COMPENSATION; DELAY OF
19	SUBSEQUENT BENEFIT YEAR

1	(a) Notwithstanding any provision of 21 V.S.A. chapter 17 to the contrary
2	an individual shall be eligible to receive or to continue to receive Pandemic
3	Emergency Unemployment Compensation benefits in lieu of regular
4	unemployment insurance benefits if:
5	(1) the individual was determined to be eligible for Pandemic
6	Emergency Unemployment Compensation during a benefit year that expired
7	after December 27, 2020;
8	(2) the individual has remaining entitlement to Pandemic Emergency
9	Unemployment Compensation benefits with respect to the expired benefit
10	year;
11	(3) the individual would qualify pursuant to 21 V.S.A. chapter 17 for
12	regular unemployment insurance benefits in a new benefit year; and
13	(4) the weekly benefit amount for regular unemployment insurance
14	benefits in the new benefit year would be at least \$25.00 less than the weekly
15	benefit amount payable on the individual's Pandemic Emergency
16	Unemployment Compensation claim in the prior benefit year.
17	(b)(1) The new benefit year of an individual who is determined to be
18	eligible to receive or to continue receiving Pandemic Emergency
19	Unemployment Compensation benefits pursuant to subsection (a) of this
20	section shall not begin until after the individual has exhausted his or her
21	eligibility for Pandemic Emergency Unemployment Compensation benefits.
