Whereas, Kate O'Connor worked for former Governor Madeleine Kunin and served with distinction as a senior staffer for the entirety of former Governor Howard Dean's gubernatorial tenure and during his historic presidential campaign, and

Whereas, she recalled her days on the presidential campaign trail in an interesting memoir entitled *Do the Impossible: My Crash Course on Presidential Politics Inside the Howard Dean Campaign*, and

Whereas, returning home to Brattleboro, Kate O'Connor followed her mother's footsteps as the respected Brattleboro Selectboard chairwoman, and

Whereas, Kate O'Connor transitioned to the nonprofit sector, serving for seven years as the effective Brattleboro Area Chamber of Commerce Executive Director, now therefore be it

House concurrent resolution honoring Ursula Dalem for her exemplary proprietorship of the Dalem Chalet in Brattleboro

Offered by: Representatives Burke of Brattleboro, Kornheiser of Brattleboro, and Toleno of Brattleboro

Whereas, in 1957, Ursula Golda, at the behest of family friend Oskar Dalem, emigrated from Germany to the United States; the couple married in 1958, and for several years they operated a turkey farm in Brattleboro, delivering poultry products to supermarkets and corner stores, and

Whereas, in the mid-1960s, the couple built the Dalem Chalet, a Brattleboro banquet facility and motel, which hosted famous guests who were both performing and attending concerts at the nearby Marlboro Music Festival, and

Whereas, after many decades of successful hospitality entrepreneurship, Ursula Dalem sold the building to the Windham & Windsor Housing Trust, which in partnership with Groundworks Collaborative has converted the property into a much-needed affordable housing facility, now therefore be it
