House concurrent resolution recognizing the important health care contribution of nurse anesthetists in Vermont

<u>Whereas</u>, nurse anesthetists were the first group of American health care professionals to administer anesthesia to surgical patients, have been primary providers of anesthesia for the U.S. military since the Civil War, and became the first clinical nursing specialty, and

<u>Whereas</u>, in 1931, the National Association of Nurse Anesthetists was founded and was later renamed the American Association of Nurse Anesthetists, and

<u>Whereas</u>, nationally, over 57,000 nurse anesthetists practice in traditional hospital surgical suites, obstetrical delivery rooms, dental offices, critical access hospitals, ambulatory surgical centers, and U.S. military, Public Health Services, and Department of Veterans Affairs health care facilities, and

<u>Whereas</u>, the week of January 24–30, 2021 has been designated as National Certified Registered Nurse Anesthetists Week, now therefore be it

That the General Assembly recognizes the important health care contribution of nurse anesthetists in Vermont, and be it further

House concurrent resolution honoring the Thomas Dairy for 99 years of agricultural and entrepreneurial excellence

<u>Whereas</u>, the changing dairy environment and the devastating impact of COVID-19 unfortunately resulted in the permanent closure of Thomas Dairy on October 1, 2020, leaving a proud legacy, now therefore be it

House concurrent resolution honoring former Brattleboro Police Chief Michael Fitzgerald

<u>Whereas</u>, Michael (Gunny) Fitzgerald earned his nickname from serving as a U.S. Marine gunnery sergeant as the capstone of his two-decade-plus military career, and

<u>Whereas</u>, on concluding his military service, Gunny Fitzgerald embarked on a new professional path as a Brattleboro law enforcement officer, and <u>Whereas</u>, municipal policing and Gunny Fitzgerald proved an eminently compatible pair, and he rose to the ranks of lieutenant and captain prior to his 2014 appointment as Brattleboro Police Chief, and

<u>Whereas</u>, Gunny Fitzgerald, who stepped down as chief at the end of 2020, viewed the police department as the community's guardian and not its warrior, and he was dedicated to working cooperatively with the Brattleboro Community Safety Review Committee, now therefore be it

House concurrent resolution in memory of historic preservation architect Martin S. Tierney of Burlington

<u>Whereas</u>, Martin Tierney earned a master's degree in architecture from Rensselaer Polytechnic Institute, and he became one of Vermont's premier experts in designing historic preservation projects, and

<u>Whereas</u>, among his career highlights were impressive endeavors at Shelburne Farms, the Elley-Long Music Center in Colchester, the Richmond Round Church, and Burlington's Union Station and Warner Block, and

<u>Whereas</u>, he chaired the Capitol Complex Commission and the Vermont Advisory Council on Historic Preservation and served on the Friends of the Vermont State House and the Preservation Trust of Vermont, and

<u>Whereas</u>, this widely respected Renaissance man, with amazingly diverse avocational interests, died in December 2020, and his survivors include his wife, Linda, his children, and his grandchildren, now therefore be it
