#### **H.C.R. 18.**

House concurrent resolution in memory of Cynthia M. (Peterson) Eastman

Offered by: Representatives Lefebvre of Orange and Graham of Williamstown

Whereas, Cynthia Eastman grew up in Topsham and Corinth, and was married for 52 years to her high school sweetheart, Larry Eastman Sr., with whom she enjoyed motorcycle riding and summer camping, and

Whereas, perhaps more significant than Cynthia Eastman's compensated employment was her long association with and dedication to the Corinth–Topsham emergency response team, and

Whereas, her volunteer service as a first responder and as the organization's treasurer was of great personal and community importance, and she would respond to calls at all hours and was known not to travel if no one else would be locally available to respond to medical emergencies, and

Whereas, Cynthia Eastman died on January 25, 2021 at 69 years of age, and her survivors include her husband, children, grandchildren, and great-grandchildren, now therefore be it

Whereas, in her two World Cup victories in Yaroslavl and Raubichi, less than a point separated the first- and second-place ski racers, reflecting the extremely competitive element of these events, and

Whereas, these two impressive wins placed Megan Nick in third place in the Freestyle World Cup standings, and

Whereas, aside from World Cup races, Megan Nick was victorious at the Nor-Am Cup in Utah, a further indication of her superb Alpine skiing skills, now therefore be it
