## H.C.R. 69.

House concurrent resolution recognizing May 2021 as EDS and HSD Awareness Month in Vermont

Offered by: Representative Jessup of Middlesex

Whereas, Ehlers-Danlos syndrome (EDS) is an inherited condition affecting the body's connective tissue, and

Whereas, hypermobility spectrum disorder (HSD) is also a tissue connectivity condition, but the symptoms associated with EDS and HSD are not identical, and

Whereas, EDS is not a commonly known malady, even in the medical community, and a decade may elapse before it is correctly diagnosed, during which an individual can suffer acute pain, and

Whereas, to increase public knowledge of EDS and HSD the Ehlers-Danlos Society observes May as EDS and HSD Awareness Month, now therefore be it

Resolved by the Senate and House of Representatives:

That the General Assembly recognizes May 2021 as EDS and HSD Awareness Month in Vermont, and be it further

House concurrent resolution remembering the life achievements of former Representative Robert Willard Cochran of Jericho and his wife, Willadine (Orton) Cochran

Whereas, Bob Cochran graduated from Indiana University, earned a PhD in English at the University of Michigan, and served as a distinguished University of Vermont professor and English department chair, and

Whereas, he sat on the Jericho Elementary School and Mount Mansfield Union High School boards, was a Jericho justice of the peace, and for the 1993 and 1995 biennia represented Jericho in the House of Representatives, and

Whereas, his wife, Willadine Cochran, was a talented artist, cofounded and taught at the Saxon Hill Pre-School, and was the first woman and first Democrat to serve on the Jericho Board of Civil Authority, and

Whereas, Willadine Cochran died in 2013 and Bob Cochran in 2020, and their survivors include three generations of descendants, now therefore be it
