House concurrent resolution recognizing July 2022 as Park and Recreation Month in Vermont and designating July 15, 2022, as Vermont Park and Recreation Professionals Day in Vermont.

Whereas, in 1985, the National Recreation and Park Association established July as Park and Recreation Month, and, in 2009, the U.S. House of Representatives adopted a resolution endorsing this national celebration of our nation's parks, now therefore be it

That the General Assembly recognizes July 2022 as Park and Recreation Month in Vermont and designates July 15, 2022, as Vermont Park and Recreation Professionals Day, and be it further

House concurrent resolution congratulating Alicia Dana on winning the Women's Road Race H1-4 cycling bronze medal at the 2020 Paralympics in Tokyo

Whereas, Alicia Dana of Putney won the gold medal in the H1-3 race at the 2014 Union Cycliste Internationale Para-cycling Road World Championships and has speedily powered her para-cycle to many subsequent victories, and

Whereas, at the 2016 Paralympics in Rio de Janeiro, Alicia Dana was the silver medalist in the H1-3 category and placed fourth in the H1-4 race, and

Whereas, at the 2020 Paralympics in Tokyo, despite having the chain on her handcycle break during the last lap, she clinched the bronze medal in the H1-4 race, reconfirming her status as one of the world's leading competitive paracyclists, now therefore be it

Resolved by the Senate and House of Representatives:
