## **Concurrent Resolutions for Adoption Under Joint Rule 16**

The following concurrent resolutions will be adopted automatically unless a Representative or Senator requests floor consideration before the end of Friday's legislative session. Requests for floor consideration must be communicated to the House Clerk's office or the Senate Secretary's office.

### **Resolutions**

#### **H.C.R. 104.**

House concurrent resolution commemorating the centennial anniversary of the Harris Hill Ski Jump in Brattleboro

Offered by: Representatives Burke of Brattleboro, Kornheiser of Brattleboro, and Toleno of Brattleboro

Offered by: Senators Balint and White

Whereas, Fred Harris, a pioneer extreme skier, invested \$2,200 to construct an Olympic-size ski jump on Cedar Street in Brattleboro, which opened in 1922, and the site's opening competition established a New England distance record, and

Whereas, the site has hosted State, regional, and national ski jump championships, some featuring international jumpers, as well as associated celebratory events, and

Whereas, in 1956, Fred Harris was inducted into the National Ski Hall of Fame, and, from 2006 to 2008, the Harris Hill Ski Jump was reconstructed, and

Whereas, in recognition of the 100th anniversary of the Harris Hill Ski Jump, a solar-lighted commemorative sculpture has been constructed and located near the Brooks Memorial Library, and this milestone will be celebrated during the 2022 competition on February 19–20, now therefore be it

Resolved by the Senate and House of Representatives:

That the General Assembly commemorates the centennial anniversary of the Harris Hill Ski Jump in Brattleboro, and be it further

Resolved: That the Secretary of State be directed to send a copy of this resolution to Harris Hill Ski Jump Inc.

**H.C.R. 105.**

House concurrent resolution in memory of former Representative Deborah G. Evans of Essex

Whereas, Debbie Evans's enthusiasm for her family and community were evident to all who were privileged to make her acquaintance, and

Whereas, she graduated from Carlow University, was recognized by her professional peers for her excellence as a school speech pathologist and an Essex Free Library Trustee, and promoted her love of books and reading and

Whereas, Debbie Evans was a dedicated municipal and State public servant, serving on the Essex Board of Civil Authority, and, for 12 years, in the House of Representatives as an able member and, for a time, vice chair of the Committee on Government Operations, and

Whereas, this admired civic leader and friend to all died on September 3, 2021, and her survivors include her husband Paul, her children, and her grandchildren, now therefore be it

Resolved by the Senate and House of Representatives:

That the General Assembly expresses its sincere condolences to the family of former Representative Deborah G. Evans of Essex, and be it further
