Whereas, the achievements of Bill O'Neil as an Essex High School athletics coach were truly incomparable, and

Whereas, most successful coaches gain notoriety in one, or possibly two, sports, but Bill O'Neil polished his coaching expertise in three sports: girls' soccer, and softball, and boys' hockey, and

Whereas, during 37 years on the soccer field, Bill O'Neil's teams won six State championships, and, over the same length of time, his softball squads brought home four State championships, and most impressively, his boys' hockey teams earned 14 State championships during the 44 years he coached them, and

Whereas, his overall record of 1,293 victories, 592 losses and 85 ties, and his 24 State championships may represent the greatest coaching success in the annals of Vermont interscholastic sports, and

Whereas, in 2018, this now-retired high school teacher and coach was honored when he became the second Vermonter inducted into the National High School Hall of Fame, and, in 2022, Bill O'Neil is earning a new accolade as the Vermont Sports Hall of Fame welcomes him to its membership, now therefore be it

Whereas, surviving residents of the former St. Joseph's Orphanage (SJO) in Burlington, where instances of physical, sexual, and emotional abuse have been documented, established the Voices of St. Joseph's Orphanage, and have engaged in a facilitated restorative inquiry, and

Whereas, the Voices of St Joseph's Orphanage played an important role in the enactment of No. 26 of 2021, "An act relating to repealing the statute of limitations for civil actions based on childhood physical abuse," and

Whereas, the group has engaged in a number of initiatives that promote education and awareness about the abuse that occurred at SJO, including the production of an anthology of writings, a partnership with the Vermont Folklife Center to record oral histories, a collaboration with the Burlington Parks and Recreation Department to create a public space to honor and memorialize the experiences of the children who lived at SJO, the creation of a traveling timeline exhibition documenting the history of what occurred, and

training for service providers on the Adverse Childhood Experiences (ACE) study, as well as on the impacts of childhood trauma, and

Whereas, the group continues its mission to hold the Roman Catholic Diocese of Burlington accountable for the harm that occurred under its oversight of SJO, and

Whereas, the Vermont Center for Crime Victims honored the organization with its Survivor/Activist Award, now therefore be it

Whereas, this fast-attack nuclear submarine was commissioned into the U.S. Navy fleet on April 18, 2020, the date on which it formally assumed the name USS VERMONT (SSN 792), and

Whereas, the U.S. Navy and the VERMONT (SSN 792) Commissioning Committee held a commemorative commissioning ceremony on August 28, 2021, continuing a proud tradition, and

Whereas, the USS VERMONT Support Group (VSG) was established to support the submarine, the crew, and their families for the life of the vessel, and

<u>Whereas</u>, the officers and enlisted personnel of the USS VERMONT have sustained superior performance, setting new standards for future U.S. Navy submarines entering the fleet, and

Whereas, throughout the COVID pandemic, the families of the USS VERMONT have remained strong, enabling the sailors to perform their missions, and

Whereas, today, the Commanding Officer, the Chief of the Boat, and 10 sailors are making an official U.S. Navy-namesake visit to the State, educating the public, touring, and performing public service, now therefore be it

Whereas, Head Coach Mary Krug, Assistant Coach Lucy Lincoln, and team manager Lila Crock contributed to the Hornets' success, now therefore be it

House concurrent resolution commemorating the 250th anniversary of the New Yorkers' capture and the Bennington posse's rescue of early Arlington leader and pre-Revolutionary War patriot Remember Baker Jr.

Offered by: Representatives James of Manchester, Bongartz of Manchester, Brownell of Pownal, Corcoran of Bennington, Durfee of Shaftsbury, Morrissey of Bennington, Nigro of Bennington, Pajala of Londonderry, Sullivan of Dorset, and Whitman of Bennington

Offered by: Senators Campion and Sears

Whereas, Remember Baker was born in Woodbury, Connecticut (later renamed Roxbury), in 1737, and, in 1764, he became one of the second wave of settlers in the Town of Arlington (a New Hampshire grant town), and, later, served as an Arlington Town Clerk, and

Whereas, on July 20, 1764, British authorities declared the land now consisting of the State of Vermont to be under New York's, and not New Hampshire's, colonial jurisdiction, and

Whereas, some of the New Hampshire grant towns tried, but failed, to repurchase the land rights from the New York authorities, and Remember Baker, his cousins, Ira and Ethan Allen, and others formed a defensive organization, later known as the Green Mountain Boys, to protect against encroachment by New York authorities, and

Whereas, Remember Baker drew the particular ire of New York authorities for threatening and ejecting New York land grant holders, and

Whereas, on March 21, 1772, a New York-appointed justice of the peace, John Munro, staged a predawn attack on Remember Baker's home, wounding Baker, his wife, and their children, and Munro's posse then proceeded to bring Baker, on a sleigh, to face New York justice in Albany, and

Whereas, neighbors Caleb Henderson and John Whiston attempted to stop the sleigh, failed, and Whiston was captured, and, learning of these events, a group of Bennington residents headed out to intercept Munro's entourage, and

Whereas, the Bennington rescuers arrived first at the Hudson River ferry crossing (now the site of Troy, New York), reversed course towards Arlington, intercepted Munro, and rescued the barely alive Baker and Whiston, and

Whereas, Baker recovered, but was killed in 1775 while on a scouting expedition in what is now Canada, now therefore be it

Whereas, CAT-TV, via local Comcast channels 1075, 1085, and 1095, and social media sites, provides diverse and informative programming that engages citizens and encourages open public dialogue, and

Whereas, CAT-TV provides both training on and access to the latest video and production studio equipment, giving citizens a platform for free speech, and opportunities to volunteer, and

Whereas, for 30 years, CAT-TV has recorded and archived the events and history of its community, including governing boards, Bennington Battle Day celebrations, graduation ceremonies, church services, election results, and other activities of community interest, now therefore be it

Whereas, starting as a Typist B on March 1, 1972, Diane Dalmasse rose through the state employee ranks to become a social worker at the former Vermont State Hospital, a casework supervisor at the Division of Vocational Rehabilitation (DVR), and, in 1991, she was promoted to the position of Director of DVR, and

Whereas, her many achievements as DVR Director have included greatly expanding the Division's clientele, facilitating an emphasis on higher-wage careers for consumers, encouraging the development of Invest EAP (Employee Assistance Program), improving DVR's Social Security Disability and Supplemental Security Income services, creating new youth programs, launching the Creative Workforce Solutions and Business Account Managers services, and overseeing DVR's rebranding as HireAbility Vermont, now therefore be it

Whereas, in 1978, he became the Norwich Cadets' men's soccer coach, and he finished his final season with a trip to the 1984 Eastern College Athletic Conference (ECAC) playoffs, and

Whereas, in 1982, Tony Mariano assumed men's hockey coaching duties, guiding his teams to three NCAA and eight ECAC playoff berths, and

Whereas, in 1987, he won personal recognition as both the Division III National Coach of the Year and the New England Coach of the Year, and, in 2022, the New England Hockey Conference named its postseason championship cups in his honor, and

Whereas, in 1992, he relinquished his coaching duties when Norwich University appointed him its Director of Athletics, and his leadership was

instrumental in the university's winning of 76 conference and 12 national championships, the completion or renovation of several athletic facilities, including the opening of Kreitzberg Arena, and he has served in important regional intercollegiate administrative and NCAA intercollegiate hockey leadership roles, and

Whereas, this 2001 Rome (New York) Sports Hall of Fame inductee and 2018 Under Armour Athletic Director of the Year is concluding his stellar Norwich University career of building a championship culture, now therefore be it
