H.C.R. 135.

House concurrent resolution designating April 27, 2022 as Alzheimer's Awareness Day at the State House

Whereas, Alzheimer's disease is a degenerative brain disease and the most common form of dementia, and

Whereas, between now and 2025, the number of Vermonters diagnosed with Alzheimer's is expected to rise from 13,000 to 17,000, and

Whereas, in 2020, the Vermont Medicaid cost for Alzheimer's care was \$116 million dollars, an amount projected to rise 26.4 percent by 2025, and

Whereas, in 2019, there were 315 Alzheimer's deaths in Vermont, the fifth highest per capita rate nationally, and

Whereas, by 2050, the number of geriatricians that will be needed to meet the health care requirements of persons with Alzheimer's and other dementia conditions in Vermont must rise 255.6 percent, and

Whereas, nationally, 6.5 million Americans are living with Alzheimer's, a number projected to double by 2050, and over 11 million serve as unpaid caregivers for these individuals, and

Whereas, the national financial impact of Alzheimer's is expected to reach one trillion dollars by mid-century, and

Whereas, annually, 26,000 Vermonters provide an estimated 37 million hours of uncompensated Alzheimer's care valued at \$758 million, and

Whereas, the medical, financial, and social impact of Alzheimer's is enormous, and advocates for the Alzheimer's community will be visiting the State House on April 27 to inform legislators of their continuing concerns, now therefore be it

Resolved by the Senate and House of Representatives:

That the General Assembly designates April 27, 2022 as Alzheimer's Awareness Day at the State House, and be it further

Whereas, as a BFA-St. Albans ice hockey player, Toby Ducolon was a key member of the school's 1982 and 1983 State championship teams, and, as a senior, he scored 38 goals and twice headed the Vermont All-State Team, and

Whereas, his University of Vermont record at Gutterson Fieldhouse was equally stellar, as he scored 46 goals and earned 39 assists during a collegiate career crowned by the team's first NCAA post-season appearance, and

Whereas, in 1984, Toby Ducolon was named to the U.S. Junior National Team, became the first Vermonter the NHL's St. Louis Blues recruited, and proceeded to skate for two years on a Blues-affiliated team, and

Whereas, in 1990, he began a 32-year reign as the Bobwhites' superb head coach, guiding his teams to 23 semifinal playoff games, 13 final appearances, nine State titles, and 450 contest victories, and

Whereas, in 2020, Toby Ducolon was deservedly inducted into the Vermont Sports Hall of Fame, and

Whereas, in 2022, Toby Ducolon is concluding his amazing coaching career, and his most important legacy has been creating a culture of consistency in behavior, consequences, and decision-making as the fundamentals for the privilege of being a Bobwhite, now therefore be it

Whereas, the FIRST Tech Challenge (FTC) is an international student robotics competition, and

Whereas, assessments of student teams are based on the students' community outreach and teamwork, and a team's design thinking and design process are major points for the judges' consideration, and

Whereas, in the tension-packed three-match final round, the RoboHawks won the first match, sustained a penalty in the second, and then rebounded in the decisive third round, defeating a combined team of South Burlington and Essex students for a 138–124 victory, and the RoboHawks stellar Vermont performance earned them an invitation to the 2022 FIRST Robotics World Championships scheduled to take place in Houston, Texas in April, and

Whereas, RoboHawks Wolfie Davis, Lindsay Beer, Jared Kennedy, Sam Yager, Violet Fennern, Jack Gourlay, Crawford Phillips, and Charlotte Tyler, under the expert guidance of their coach, Olaf Verdonk, mastered the robotic technicalities and group dynamics needed for this victory, now therefore be it
