House concurrent resolution congratulating E.J. Barrette & Sons Inc. of Swanton on its centennial

Whereas, E. J. (Jeffrey) Barrette was born in 1891, and in 1922, his long fascination with the horseless carriage, by then known as the automobile, inspired him to secure a dealership from the Ford Motor Company and open his new business on the western side of Canada Street in Swanton, and

Whereas, popular legend relates that the Barrette family patriarch, who sold his first car, a Model T, on February 22, 1922, taught his early customers how to drive, sold them a car, and then administered the driver's license examination, and

Whereas, in 1930, the business's success prompted him to move the dealership to a more suitable building on the eastern side of Canada Street; in 1955, with his son Weldon having joined the operation, it was incorporated as E.J. Barrette & Sons Inc.; and, a few years after the senior Barrette's death in 1979, the business, popularly known as Barrette Ford, moved to a new and spacious facility outside the Village of Swanton on Route 78, and

Whereas, prior to his death in 2012, Weldon had brought his son, Jon, into the business, and the dealership's leadership team now includes Jon's wife, Linda, his sister, Paula, and the fourth Barrette generation, his children Aaron, Meredith, and Sarah, and

Whereas, in recognition of Barrette Ford's operational excellence, the Ford Motor Company recently honored its second-oldest Vermont dealership with its President's Award, now therefore be it

Ryan, RSM was born on a dairy farm in Fairfield in 1936, graduated from Mount Saint Mary Academy and Trinity College in Burlington, earned a master's degree in special education from Boston University, and completed graduate studies at Harvard University and the University of Lund in Sweden, and

Whereas, in 1957, she took vows as a new member of the Congregation of the Sisters of Mercy, and, as a Sister for 68 years, she dedicated her life to advancing social justice—in education, for Vermonters with disabilities, and for those involved in the State's criminal justice system, and

Whereas, Sister Janice served as president of Trinity College from 1979 to 1996, influencing education at all class levels and showing young women that education was a critical way to develop social and economic power, and

Whereas, she insisted throughout her career that with power comes a responsibility for using that power for good, and

Whereas, she exuded humor and pragmatism, possessed an ability to appreciate small victories and moments of beauty, and delighted in burnt hot dogs, and

Whereas, her efforts to encourage leaders across the political spectrum, particularly women, boosted their confidence to strive toward ends they would never have imagined possible, and

Whereas, the source of Sister Janice's influence lay less in her varied positions of authority than in the respect and desire for connection she brought to every conversation, and

Whereas, throughout her life, Sister Janice reflected the clarity of purpose, deep compassion, and radical hospitality of her congregation and its Vermont members who have played a critical role in affirming the dignity of all Vermonters, now therefore be it

Resolved by the Senate and House of Representatives:

That the General Assembly extends its sincere condolences to the family of Sister Janice E. Ryan, RSM and its gratitude to the members of her spiritual family, the Sisters of Mercy, and be it further

Whereas, George Severance spent his youth in Shoreham, and

Whereas, in 1962, he enlisted in the U.S. Navy and proudly served on the maiden cruise of the aircraft carrier USS Enterprise, and

Whereas, after his naval discharge in 1965, George Severance started a successful career at IBM that lasted more than three decades, and

Whereas, while gainfully employed, he pursued a college degree, majoring in business, with an education minor that later proved important, and

Whereas, upon retiring from IBM, George Severance became an educator, working at Winooski High School, Hinesburg Middle School, and, for over 15 years, at Mount Mansfield Union High School, and

Whereas, George Severance, who was an avid golfer, and New York Yankees and New York Giants fan, died on April 3, 2022, and his survivors include his wife, Martha, children, and grandchildren, now therefore be it
