1	TO THE HOUSE OF REPRESENTATIVES:
2	The Committee on Agriculture and Forestry to which was referred Senate
3	Bill No. 258 entitled "An act relating to agricultural water quality,
4	enforcement, and dairy farming" respectfully reports that it has considered the
5	same and recommends that the House propose to the Senate that the bill be
6	amended by striking out Sec. 10, effective date, in its entirety and inserting in
7	lieu thereof new Secs. 10–12 to read as follows:
8	Sec. 10. 6 V.S.A. § 4802 is amended to read:
9	§ 4802. DEFINITIONS
10	As used in this chapter:
11	***
12	(2) "Farming" has the same meaning as used in 10 V.S.A. § 6001(22).
13	(3) "Good standing" means a participant in a program administered
14	under this chapter:
15	(A) does not have an active enforcement violation that has reached a
16	final order with the Secretary; and
17	(B) is in compliance with all terms of a current grant agreement or
18	contract with the Agency.
19	***
20	(10) "Agricultural activities" mean the operation and management of an
21	entity engaged in farming including any condition or activity that occurs at any

1	time on a farm, including all those activities defined as "farming" in this
2	chapter, "agricultural activity" in 12 V.S.A. § 5752, and all of the following:
3	(A) selling agricultural products at roadside stands or farm markets;
4	(B) the generation of noise, odors, dust, fumes, and other associated
5	conditions;
6	(C) the composting of material principally produced by the farm or to
7	be used at least in part on the farm;
8	(D) the ditching and subsurface drainage of farm fields and the
9	construction of farm ponds;
10	(E) the handling of livestock wastes and by-products;
11	(F) the operation of farm machinery and equipment, including
12	irrigation and drainage systems, pumps, and on-farm grain dryers;
13	(G) the movement of farm vehicles, machinery, equipment, and
14	products and associated inputs on the roadway;
15	(H) field preparation, crop protection, and ground and aerial seeding
16	and spraying;
17	(I) the on-site storage and application of agricultural inputs, including
18	lime, fertilizer, organic materials, conditioners, and pesticides;
19	(J) the use of alternative pest management techniques;
20	(K) the management, storage, transport, utilization, and application of
21	farm by-products, including manure or agricultural wastes;

1	(L) the expansion, change, or conversion of farming practices or
2	agricultural activities on a farm; and
3	(M) the employment, use, and housing of farm labor.
4	Sec. 11. 6 V.S.A. § 4818 is added to read:
5	§ 4818. FARMING; SCOPE OF ACTIVITIES
6	(a) As used to determine the scope of nuisance protection in 12 V.S.A.
7	chapter 195, "agricultural activities" shall include "farming" as defined in this
8	title.
9	(b) For purposes of application of 12 V.S.A. § 5753, all "agricultural
10	activities" defined in this chapter are entitled to the rebuttable presumption that
11	they do not constitute a nuisance.

13	This act shall take effect on passage.
