Vermont Coronavirus Emergency Economic Recovery Grant Award

The above Vermont Coronavirus Emergency Economic Recovery Grant has been awarded on a one-time basis from the Coronavirus Relief Fund (CRF) established under the federal Coronavirus Aid, Relief, and Economic Security (CARES) Act to address necessary expenditures with respect to the Coronavirus Disease 2019 (COVID-19) public health emergency. This grant is being issued to help provide economic support to your business, which has been impacted by decreased customer demand due to the COVID-19 public health emergency.

Background

The Vermont Agency of Commerce and Community Development is authorized to issue grant funds to businesses that experienced significant revenue loss during the pandemic.

Conditions of Receipt

You do not need to take any action to accept the grant funds. The grant award information for your Vermont Coronavirus Emergency Economic Recovery Grant is provided under General Grant Information above. That section outlines the amount of grant funds that have been issued to your business, as a paper check that is being sent to you through the US Mail.

The funds from this grant can be used to pay necessary expenditures that your business faces and costs directly associated to your business's response to COVID-19. If it is found that this grant was issued due to error, misrepresentation of facts, or fraud in your application, you will be required to return the funds to the Vermont Agency of Commerce and Community Development.

Duplication of Benefits

Businesses that have a duplication of benefits may need to repay a portion of the grant later if it appears that the total grant proceeds from the Vermont Economic Recovery Grant plus any forgiven PPP loans, EIDL Advance grants, and other federal grants or credits exceed the aggregate amount of the business's losses in 2020.

On the grant application, ACCD collects information about amounts a business received in PPP loans, EIDL Advance grants, and any other federal grant or credit reimbursement for COVID-19 related

damages or expenses. Federal guidelines indicate that businesses cannot receive a duplication of benefits for COVID-19 relief. On the application, the ACCD requires a business to certify that they will not use their Vermont Economic Recovery Grant to cover any expenses for which they have already received other reimbursement.

Records Available for Audit

The grantee shall maintain all records pertaining to performance under this agreement. Records means any written or recorded information, regardless of physical form or characteristics, which is produced or acquired by the grantee in the performance of this agreement. Records produced or acquired in a machine readable electronic format shall be maintained in that format. The records described shall be made available at reasonable times during the period of the award and for three years thereafter or for any period required by law for inspection by any authorized representatives of the State or Federal Government. If any litigation, claim, or audit is started before the expiration of the three-year period, the records shall be retained until all litigation, claims or audit findings involving the records have been resolved.

Requirements Pertaining to Federal Grants and Subrecipient Agreements: This Agreement is a grant that is funded in whole by Federal funds:

Requirement to Have a Single Audit (Non-Profit Organizations): The Subrecipient will complete the Subrecipient Annual Report annually within 45 days after its fiscal year end, informing the State of Vermont whether or not a Single Audit is required for the prior fiscal year. If a Single Audit is required, the Subrecipient will submit a copy of the audit report to the granting Party within 9 months. If a single audit is not required, only the Subrecipient Annual Report is required.

For fiscal years ending before December 25, 2015, a Single Audit is required if the subrecipient expends \$500,000 or more in Federal assistance during its fiscal year and must be conducted in accordance with OMB Circular A-133. For fiscal years ending on or after December 25, 2015, a Single Audit is required if the subrecipient expends \$750,000 or more in Federal assistance during its fiscal year and must be conducted in accordance with 2 CFR Chapter I, Chapter II, Part 200, Subpart F. The Subrecipient Annual Report is required to be submitted within 45 days, whether or not a Single Audit is required.

Internal Controls (All Organizations): In accordance with 2 CFR Part II, §200.303, the Party must establish and maintain effective internal control over the Federal award to provide reasonable assurance that the Party is managing the Federal award in compliance with Federal statutes, regulations, and the terms and conditions of the award. These internal controls should be in compliance with guidance in "Standards for Internal Control in the Federal Government" issued by the Comptroller General of the United States and the "Internal Control Integrated Framework", issued by the Committee of Sponsoring Organizations of the Treadway Commission (COSO).

Mandatory Disclosures (All Organizations): In accordance with 2 CFR Part II, §200.113, Party must disclose, in a timely manner, in writing to the State, all violations of Federal criminal law involving fraud, bribery, or gratuity violations potentially affecting the Federal award. Failure to make required disclosures may result in the imposition of sanctions which may include disallowance of costs incurred, withholding of payments, termination of the Agreement, suspension/debarment, etc.
