Thank you for the opportunity to testify before you this afternoon. Below I have outlined the Office of Professional Regulation's position on the changes made to H.157 at the end of last session.

OPR supports this change. It was not the intent to dually regulate professions that are regulated by DPS. OPR will clearly point consumers to DPS if they are looking for a DPS professional.
