

Re-Housing Recovery Program

• \$6.2 million - rehabilitate vacant, blighted, code non-compliant rental units

- Focus on re-housing homeless and at-risk
- Maintain rental affordability
- DHCD partnered with the 5 Homeownership Centers
 - HOCs identified private landlords and monitored work

Landlords eligible up to \$30,000/unit

- At least 10% match
- Communication with Continua of Care – at least 3 referrals reviewed
- 5-year affordability covenant
- Completion by Dec 20, 2020 deadline*

• 218 total units affected

- 143 online before 12/20/20
- 75 by March 2021
- Average grant \$23,000
- Increased communication between property owners and Continua of Care

• HOC interest to continue program through 2021
