2	(pedestrians to use right half of crosswalks), 1055 (pedestrians on roadways),

4	(G) 23 V.S.A. § 1125 (obstructing windshield or windows);
5	(H) 23 V.S.A. §§ 1134 (possession or consumption of alcohol or
