RE: Executive Branch Seasonal Employee Reports – CY 2021

The enclosed report on seasonal employees in calendar year 2021 is submitted by DHR Commissioner Beth Fastiggi on behalf of Secretary of Administration Kristin Clouser, in accordance with 3 V.S.A. §331c(3).

In summary, four positions in seasonal employment were authorized for a period of between seven and 12 months during the prior calendar year. Departments employed 11 additional seasonal positions for which they did not obtain authorization to work more than seven months. Three of these employees were terminated.

Two seasonal positions have continued to work in the 2022 calendar year.

The department employing the seasonal positions and the length of time each position has been authorized for is attached.
