Re: Profession Types that should be considered for inclusion in H.655

The Office of Professional Regulation has 58 profession types that could use a telehealth registration or license. The Office is aware that a majority of these profession types utilized the Act 6 licensure flexibilities during the preceding two years. However, OPR does not believe current professional scopes of practice, as established in statute, allow out-of-state professionals from all of the below profession types to practice telehealth in Vermont. Below is a list of recommendations regarding which health care profession types should be included or excluded from H. 655.¹

¹ Importantly, H. 655 limits telehealth licensure and registration to professionals that have the same scope of practice and form of licensure in their home state.

² The "practice of acupuncture" is defined by physical, in-person insertion of fine needles and other means of skin stimulation techniques and embraces diagnosis only for the purpose of developing a plan of acupuncture care. 26 V.S.A. §§ 3401(1).

³ Chiropractic Interns are only allowed to work under the direct supervision of a licensed chiropractor. 26 V.S.A. § 536. It is unlikely that an out of state chiropractic intern will be providing telehealth care to a Vermonter.

⁴ Dental assistants are generally engaged to provide chairside, physical assistance "in the office of any licensed dentist consistent with rules adopted by the Board and in public or private schools or institutions under the supervision of a licensed dentist …" 26 V.S.A. § 642. To the extent a dental assistant could be engaged to provide health education on oral hygiene and care by televisual means, general health education is not a regulated activity requiring a license or registration.

⁶ Hearing Aid Dispensers are authorized to dispense hearing aids. This activity is described in 26 V.S.A. Section 3281. It is a function that requires in person visits.

⁷ Licensed nursing assistants are authorized to practice under the delegation of a nurse. LNAs should not be exercising independent nursing judgment while conducting patient care.

⁸ The optician and optician trainee scope of practice does not require interaction with patients or clients and does not include activities that can be performed using telehealth. 26 V.S.A. Section 2651(2) (""Optician" is a person who is qualified and licensed under this chapter to interpret and fill prescriptions of ophthalmologists or optometrists for ophthalmic lenses or repair and reproduce previously prepared ophthalmic lenses and frames, prepare and deliver work orders to technicians engaged in grinding lenses and fabricate eyewear, verify the accuracy of ophthalmic lenses, and adjust and disperse lenses, specially fabricated optical devices, frames, and appurtenances.")

¹⁰ A telehealth registration is unnecessary for pharmacy interns because conventional registration is available at \$20 for initial licensure and \$45 for biennial renewal. 26 V.S.A. § 2046. More than half of an internship must occur in person, under direct supervision of a pharmacist, and programs are structured primarily by schools of pharmacy, not the Vermont Board. *Id.* § 2032(b)(3).

¹¹ All of the radiology profession types should be excluded from a telehealth license or telehealth registration. All of the activities under regulated under Chapter 51 of Title 26 require direct application of different forms of radiology to a person. This activity cannot be done remotely. See, 26 V.S.A. § 2801
