SUBJECT: Mental Health Care Expenditures

The following information is submitted for the consideration of the House Committee on Health Care following requests from the Committee to the Department of Mental Health and Department of Vermont Health Access. The departments worked together to provide an overview of total mental health expenditures in calendar year 2021, inclusive of total expenditures for inpatient and outpatient mental health services, regardless of departmental budget. This table is meant to be responsive to the Committee's combined request; following the Committee's initial review of the information below, the Departments of Mental Health and Vermont Health Access recognize that more data and/or refinement may be needed.
