5	the rulemaking requirement for portions of the system of care plan; (2) require
6	system of care plan extensions to be approved by the Chairs of the House
7	Committee on Human Services and the Senate Committee on Health and
8	Welfare; (3) establish the Residential Program Developer position and
9	additional Quality Services Review Team positions within the Department for
10	Disabilities, Aging, and Independent Living; (4) establish pilot planning grants
11	to develop housing and residential services programs for individuals with
12	developmental disabilities; and (5) implement processes for payment reform
13	and conflict-free case management.

1	It is hereby enacted by the General Assembly of the State of Vermont:
2	* * * Legislative Intent * * *
3	Sec. 1. LEGISLATIVE INTENT
4	It is the intent of the General Assembly that:
5	(1) individuals who qualify for developmental services and who meet a
6	funding priority as outlined in the State system of care plan for developmental
7	services receive full and complete information regarding their options and
8	services; and
9	(2) individuals with developmental disabilities, their family members,
10	allies, and advocates be respected and active participants in systems change
11	activities, including payment reform, development of resources to comply with
12	the federal home- and community-based services regulations, and development
13	of additional residential service options.

15	Sec. 2. 18 V.S.A. § 8725 is amended to read:
16	§ 8725. SYSTEM OF CARE PLAN
17	(a) Every three years, the Department shall adopt a plan for the nature,
18	extent, allocation, and timing of services consistent with the principles of
19	service set forth in section 8724 of this title that will be provided to people
20	with developmental disabilities and their families. Each plan shall include the

1	following categories, which shall be adopted by rule pursuant to 3 V.S.A.
2	<del>chapter 25:</del>
3	(1) priorities for continuation of existing programs or development of
4	new programs;
5	(2) criteria for receiving services or funding;
6	(3) type of services provided; and
7	(4) a process for evaluating and assessing the success of programs.

9	(c) No Not later than 60 days before adopting the proposed plan, the
10	Commissioner shall submit it to the Advisory Board established in section
11	8733 of this title, for advice and recommendations, except that the
12	Commissioner shall submit those categories within the plan subject to 3 V.S.A.
13	chapter 25 to the Advisory Board at least 30 days prior to filing the proposed
14	plan in accordance with the Vermont Administrative Procedure Act. The
15	Advisory Board shall provide the Commissioner with written comments on the

19	(f) If the Department requires an extension to complete the system of care
20	plan, it shall submit a written request indicating the anticipated completion

3	upon the approval of both the Chairs of the House Committee on Human
4	Services and the Senate Committee on Health and Welfare.

13	The Department shall plan, coordinate, administer, monitor, and evaluate
14	State and federally funded services for people with developmental disabilities
15	and their families within Vermont. The Department shall be responsible for
16	coordinating the efforts of all agencies and services, government and private,
17	on a statewide basis in order to promote and improve the lives of individuals
18	with developmental disabilities. Within the limits of available resources, the
19	Department shall:

7	There is created an additional Quality Services Review Team within the
8	Developmental Disabilities Services Division of the Department of
9	Disabilities, Aging, and Independent Living for the purposes of providing at
10	least annual on-site quality assurance and improvement visits to the designated
11	and specialized service agencies. The Quality Services Review Team shall
12	assess designated and specialized service agencies' provision of services in
13	accordance with the individualized service plan for individuals served. The
14	Quality Services Review Team shall consist of a supervisor, a nurse reviewer,
15	and three Quality Services Review Team positions.

18	There is created a limited service position of the Residential Program
19	Developer within the Department of Disabilities, Aging, and Independent
20	Living for the purposes of:

1	(1) expanding housing and residential services options for individuals
2	with developmental disabilities, in accordance with federal home- and
3	community-based services regulations;
4	(2) assisting individuals with developmental disabilities and their
5	families navigate publicly and privately funded housing and residential
6	services options;
7	(3) investigating public and private funding opportunities for residential
8	program development for individuals with developmental disabilities;
9	(4) working with individuals with developmental disabilities, their
10	families, and allies to identify potential models for residential services;
11	(5) developing requests for proposals and identifying at least three pilot
12	planning grants for different regions of the State focused on the needs
13	identified in those regions; and
14	(6) working with appropriate designated and specialized service
15	agencies or other providers to implement selected pilots.

17	Sec. 5. DEPARTMENT OF DISABILTIIES, AGING, AND INDEPENDENT
18	LIVING; DEVELOPMENT OF HOUSING AND RESIDENTIAL
19	SERVICES PILOT PLANNING GRANTS
20	(a) The Department for Disabilities, Aging, and Independent Living shall
21	work with the Vermont Developmental Disabilities Council to review housing

1	models in other states for the purpose of informing the pilot planning grants
2	developed pursuant to subsection (b) of this section.
3	(b) In fiscal year 2023, \$500,000.00 is appropriated to the Department of
4	Disabilities, Aging, and Independent Living from the Global Commitment
5	Federal Medical Assistance Percentage (FMAP) home- and community-based
6	services monies to develop housing and residential service pilot planning
7	grants in at least three regions of the State, in partnership with designated and
8	specialized service agencies, for individuals with developmental disabilities
9	and their families. The pilot planning grants shall reflect the diversity of needs
10	expressed by individuals with development disabilities and their families,
11	including individuals with high support needs who require 24-hour care and
12	those with specific communication needs. The pilot planning grants shall be
13	consistent with the federal home- and community-based services regulations
14	and include new service-supported housing models. The Department shall
15	issue a request for proposals seeking entities to develop regional pilot planning
16	grants with not more than one grant per region.
17	(c)(1) The Department shall convene a steering committee to provide
18	advice and guidance as it develops and selects the pilot planning grants
19	required pursuant to this section.
20	(2) The steering committee shall be composed of the following
21	members:

1	(A) three individuals with a developmental disability, appointed by
2	the Green Mountain Self Advocates;
3	(B) two family members of individuals with a developmental
4	disability, appointed by the Vermont Family Network;
5	(C) two advocates who are either individuals with a developmental
6	disability or a family member of an individual with a developmental disability
7	appointed by the State Program Standing Committee and the Advisory Board
8	established pursuant to 18 V.S.A. § 8733; and
9	(D) two representatives of the designated and specialized service
10	agencies, appointed by Vermont Care Partners.
11	(3) The steering committee shall have the technical, legal, and
12	administrative assistance of the Department.
13	(4) Members of the steering committee shall be entitled to per diem
14	compensation and reimbursement of expenses as permitted under 32 V.S.A.
15	§ 1010 for not more than five meetings. These payments shall be made from
16	monies appropriated to the Department.
17	(d) On or before January 15, 2023, the Department shall submit a report to
18	the House Committee on Human Services and to the Senate Committee on
19	Health and Welfare describing the pilot planning grant selection process and
20	the plan for future implementation.

2	Sec. 6. PAYMENT REFORM AND CONFLICT-FREE CASE
3	MANAGEMENT
4	(a) Prior to implementing system-wide payment reform impacting
5	individuals with developmental disabilities, their families, and designated and
6	specialized service agencies, the Department of Disabilities, Aging, and
7	Independent Living shall seek approval from the General Assembly. At a
8	minimum, the following shall be included in the payment reform process:
9	(1) in addition to any standardized assessment utilized by the
10	Department, a process for consideration of additional information relevant to
11	the life circumstances of service recipients or applicants;
12	(2) in addition to any standardized rates or rate ranges developed by the
13	Department, a process for consideration of budgets to reflect the individualized
14	support needs of service recipients or applicants; and
15	(3) a process for evaluating the fiscal and service impact on individual
16	service recipients and the designated and specialized service agencies.
17	(b)(1) Prior to implementing the federally required conflict-free case
18	management system, the Department shall seek and consider input from a
19	variety of stakeholders, including individuals with developmental disabilities,
20	their families, designated and specialized service agencies, and other providers
21	and advocates and seek approval from the General Assembly.

1	(2) As part of the changes necessary to come into federal compliance,
2	consideration shall be given to performing initial clinical eligibility and service
3	planning within the Department.

5	Sec. 7. HOME- AND COMMUNITY-BASED SERVICE SPENDING PLAN
6	AMENDMENT
7	The Agency of Human Services shall seek to amend its federal Home- and
8	Community-Based Service Spending Plan to enable the Department of
9	Disabilities, Aging, and Independent Living to use Global Commitment
10	Federal Medical Assistance Percentage (FMAP) home- and community-based
11	services monies to fund the new Residential Program Developer position
12	created in Sec. 4 and the pilot planning grants in Sec. 5 of this act.
