Dear Representatives Whitman, Brumstead, Small, Pajala and Pugh,

Thank you for meeting with us to discuss your concerns about access to care and our state's opioid crisis response. I wanted to follow up with some information from our experience with Blue Cross members.

Our pharmacist Rita, pulled the recent MAT claims for our members. Only 23 claims (0.5%) hit the quantity limit that we talked with you about on Monday. A few of these were mis-entries by the pharmacy that were subsequently corrected. The majority were attempting to get more than a 30-day supply, not a higher dose. We limit <u>all</u> controlled substances to a supply of 30 days or less. Not one provider has requested a prior authorization for a dose that is higher than the FDA limit. After reviewing this data, while Blue Cross does have a Quantity Limit (limiting to FDA label dose) for Suboxone, Zubsolv and Bunavail, we do not believe that this policy is a barrier to appropriate care.

We really appreciate the discussion and look forward to supporting your work where we are able. I'm happy to answer additional questions if possible, Sara
