19	their consensus view, updates to the weights every five years and report to the

21	and transportation reimbursement not less than every five years and to delay
22	the implementation date by a year in order to provide school districts with time
23	to prepare their budgets. States that updates to the weights may include
24	recalibration, recalculation, adding or eliminating weights, or any combination
