18	(2) "Farming" has the same meaning as used in 10 V.S.A. § 6001(22).		
19	(3) "Good standing" means a participant in a program administered		
20	under this chapter:		

1	(A) does not have an active enforcement violation that has reached a		
2	final order with the Secretary; and		
3	(B) is in compliance with all terms of a current grant agreement or		
4	contract with the Agency.

6	(10) "Agricultural activities" means the operation and management of		
7	an entity engaged in farming, including all those activities defined as		
8	"farming" in this chapter, "agricultural activity" in 12 V.S.A. § 5752, and all of		
9	the following:

11	(B) the generation of noise, odors, dust, fumes, and other associated		
12	conditions;
