SUBJECT: Request for Accounting of Spending-to-Date from the HCPS Appropriation

Dear Madam Chair,

In response to the follow-up questions AHS received on December 30, 2021, please accept the updated table for the HCPS program. Over the course of the two weeks since AHS submitted the initial report, final obligations have solidified, and agreements were executed. Additional details accompany the table below for line items marked with an *. As noted in our December 16th response, there was an additional \$13,210,651 of CRF spending outside of the HCPS appropriation for DAs/SSAs.
