### **An Introduction to Vermont’s Micro Business Development Program: 31 Years Strong**

Since 1988, the five Vermont Community Action Agencies (CAAs) have successfully led the Micro Business Development Program (MBDP) and enabled low and moderate-income Vermonters to achieve and sustain the dream of entrepreneurship.

Vermont’s micro business economy is robust, with more than 50% of small businesses identified as micro, employing 5 or fewer employees including the owner. Within this micro business community are the clients served by Vermont’s Community Action Network. The clients we work with differ from the traditional start-up business owner who may have the education, and the financial backing from family, investors, or access to adequate business capital. In contrast, our clients are low-income (80% of median income or lower) and often need individualized intensive counseling to turn their dream into a reality. While they come to us with a strong and viable vision, many lack savings or access to capital, due to limited banking relationships and poor or no credit history, making it difficult to launch a business. Additional barriers to success can include physical and mental health disabilities, housing and transportation insecurity, and lack of education and training. Due to myriad barriers, our entrepreneurs are often passed over by other small business counseling programs that are suited to better educated, better resourced individuals. **Thankfully, there is a resource for them in the Vermont MBDP** where our counselors not only help disadvantaged Vermonters realize their entrepreneur capabilities, but also connect them to resources within the Community Action network and partner agencies that help them reach their full potential including food, fuel, shelter, mental health counseling, and personal financial management classes and coaching.

# MBDP RESULTS 2020

Out of devastation can emerge innovation and opportunity. Even before COVID-19, Vermont’s economy had shifted towards Micro Business. Gone are the large manufacturing giants opening the door for local Micro businesses. In Vermont, over 50% of all businesses in the State are now microbusinesses (2016). With 10,671 microbusinesses already established, this sector of business is a critical growth engine to our economy and current recovery efforts. Across the country, an estimated 92% of businesses are considered microbusinesses. Our vision is a sustainable path forward for our clients utilizing our years of expertise in starting and growing profitable microbusinesses in Vermont.

# E.M.B.R.A.C.E. GRANT RESULTS 2020

---

In response to COVID-19, The Vermont Community Action Partnership and The Micro Business Development Program have come together to establish the E.M.B.R.A.C.E. (**E**conomic **M**icro **B**usiness **R**ecovery **A**ssistance for the **C**oVID-19 **E**pidemic) direct grant program to support Vermont micro businesses owned by an individual with a "household" income at or under 80% of state median "household" income.

- ❖ We supercharged the Micro Business Development Program by increasing capacity with five new counselors needed to meet the growing demand of existing and future micro-entrepreneurs.
- ❖ The statewide Project E.M.B.R.A.C.E. Coordinator supported the counselors in achieving program outcomes, produced public data and reporting, led the development of the MBDP.org web site and implemented marketing/outreach efforts to increase the program's visibility.
- ❖ Created the MBDP.org website in partnership with ETERNITY MARKETING a local Vermont based company. MBDP.org is a central location and access point for all MBDP clients to connect with region specific counselors (and coaching in a remote setting), education tailored to micro businesses, webinars, videos, templates for budgeting, and other tools for success.

**Results Round #1-** Project E.M.B.R.A.C.E. met all goals and objectives in less than **60 days** we processed and distributed **206** individual grants to micro businesses totaling **\$1,011,879.37**.

**Results Round #2-** In less than one month from November 5<sup>th</sup> to December 1<sup>st</sup> Project E.M.B.R.A.C.E processed and approved an astounding **230** with no increased administration cost. We adapted to the existential threat of COVID-19 by the rapid development and launch of Project E.M.B.R.A.C.E. under stay-at-home orders by utilizing the existing Micro Business Development Program network. To date we have approved over **436** micro business grants averaging **\$4,825** and totaling over **\$2,100,000**. The E.M.B.R.A.C.E. grant is so important that **81.6%** of all grant applicants stated that the E.M.B.R.A.C.E. grant would **"Prevent them from going out of business"**.

- 61.7% of all applicants are from female or minority owned business.
- 38.8% of applicants have children living at home.
- 84% Rely on self-employment for household income.
- 89.3% of applicants are Sole Proprietors or Single Member L.L.C.
- 50.3% of applicants have at least 1 employee.
- 98% of all applicants have not received any business financial relief before E.M.B.R.A.C.E.






