EXECUTIVE SUMMARY

Personally identifiable information, as defined in 9 V.S.A. § 2430, and street addresses, e-mail addresses, telephone numbers, and/or demographic information allow Vermont state government to protect the health, safety and rights of, and to provide services to, Vermont residents. This report, written in response to Section 1 of Act 89 (2020), addresses:

- 1) The collection and management of personally identifiable information, as defined in 9 V.S.A. § 2430, and of street addresses, e-mail addresses, telephone numbers, and demographic information, by the Executive, Judicial and Legislative branches of Vermont State government; and
- 2) Arrangements or agreements, whether verbal or written, between branches of State government or between branches and nonstate entities, including municipalities, to share personally identifiable information, as defined in 9 V.S.A. § 2430, and street addresses, e-mail addresses, telephone numbers, and demographic information.

Approximately 370 state statutes and 150 administrative or court rules (including administrative orders of the Supreme Court) requiring the collection and management of one or more of the data elements defined as personally identifiable information in 9 V.S.A. § 2430 or the collection and management of street addresses, e-mail addresses, telephone numbers, and/or demographic information were identified and audited for this report. The branch(es) of State government and other public agencies cited in these statutes and rules were also identified to support case-by-case assessments of the specific risk of collecting, managing and disclosing personally identifiable information or street addresses, e-mail addresses, telephone numbers, and/or demographic information. More than 1,350 unique cases were identified.

An overview of the inventorying and auditing process and the data elements aggregated for this report are in the *Act 89 Inventories* section and the detailed inventories are in Appendices A – F. Also in the *Act 89 Inventories* section is a summary of arrangements or agreements to share personally identifiable information or street addresses, e-mail addresses, telephone numbers, and demographic information.

The *Findings and Recommendations* section of includes suggestions for the General Assembly. It is important to note here that 9 V.S.A. § 2430, specifically the definition of “personally identifiable information” was amended by Act 89 of 2020 to include information that are not examples of discreet digital data elements. Therefore, legal requirements related to the following are not included in this report: (1) genetic information; (2) health records or records of a wellness program or similar program of health promotion or disease prevention; and (3) health care professional’s medical diagnosis or treatment of the consumer. The *Findings and Recommendations* section of this report includes a suggestion on how to address this matter.

ACT 89 INVENTORIES

Federal and State Laws, Rules and Regulations

Section 1 of Act 89 (2020) requests an inventory of personally identifiable information, as defined in 9 V.S.A. § 2430, and of street addresses, e-mail addresses, telephone numbers, and demographic information, by the Executive, Judicial and Legislative branches of Vermont State government, specifically Federal and State laws, rules, and regulations that:

- Exempt personally identifiable information from public inspection and copying pursuant to 1 V.S.A. § 317;
- Require personally identifiable information to be produced or acquired in the course of State government business;
- Specify fees for obtaining personally identifiable information produced or acquired in the course of State government business; and
- Require personally identifiable information to be shared between branches of State government or between branches and nonstate entities, including municipalities.

To successfully fulfill this request, the Chief Data Officer and Chief Records Officer, in collaboration with the State Court Administrator and Director of Information Technology for the Legislative Branch, elected to leverage the work of records and information management (RIM) specialists within the Vermont State Archives and Records Administration (VSARA), a division of the Office of Secretary of State. Under the Statewide Records and Information Management Program (3 V.S.A. § 117), VSARA RIM Specialists routinely compile and analyze data sets of legal recordkeeping requirements for all three branches of state government to support the better management of Vermont public records and information, including data. In addition, each branch of state government has an assigned VSARA RIM Specialist.

In auditing legal requirements for this legislative report, VSARA RIM Specialists aggregated state statutes and rules by individual PII data elements, as defined in 9 V.S.A. § 2430, and the additional data elements requested in Act 89. Due to variations in terminology within the statutes and rules in comparison to the terminology in 9 V.S.A. § 2430 and Act 89, variations for some of the data elements were also all used in the aggregation.

Important to note are complications related to the Governor’s March 15, 2020 Executive Order declaring a State of Emergency in Vermont in response to the COVID-19 pandemic and addendums ordering mitigations to slow the spread of the virus impacted the normal operations of State government and availability of resources. As a result, VSARA RIM Specialists were unable to compile and audit Federal regulations at the same depth and analyses as State statutes and rules and Federal regulations, therefore, are excluded from this report.

Specific to Section 1 of Act 89, VSARA RIM Specialists also compiled data on:

- The specific State and local government entity or entities, including individual agencies and departments within the Executive branch, to which each statute or rule applies;
- The specific data element(s) cited in the statute or rule required to be produced or acquired in the course of State Government business;
- Whether the data element(s) in the statute or rule were exempt from public inspection or copying under Vermont’s public records act;
- Whether the data element(s) in the statute or rule specifies a fee for obtaining the data element(s) or the record(s) the data element(s) is contained therein; and
- Whether the data element(s) in the statute or rule is required to be exchanged between specific State and local government entities.

Appendices A – F contain extracts of the data compiled by VSARA RIM Specialists and these appendices constitute the inventories requested in Section 1 of Act 89. Additional data sets and queries are available and legislative committees and individual legislators interested in more specific or detailed data are encouraged to contact the Vermont State Archives and Records Administration.

Relating to fees for obtaining any of one or more of the data elements audited for this report, only one statute, 23 V.S.A. § 114, which relates to the Department of Motor Vehicles, was found. Data can only be provided “for purposes permitted under law, including the Driver's Privacy Protection Act, 18 U.S.C. chapter 123 as amended.” All other examples of fees relate to actual costs charges under the Vermont Public Records Act or fees allowed under the law for copies or certified copies of specific records that may contain one or more of data elements, e.g. certified copies of vital records.

Arrangements or Agreements (Written or Verbal)

Also requested in Section 1 of Act 89 (2020) is an inventory of arrangements or agreements, whether verbal or written, between branches of State government or between branches and nonstate entities, including municipalities, to share personally identifiable information, street addresses, e-mail addresses, telephone numbers, and demographic information.

Appendices G contains the requested inventory. As with the inventory of Federal and State laws, rules and regulations, complications related to the Governor's March 15, 2020 Executive Order declaring a State of Emergency in Vermont impacted the availability of state personnel to respond to requests for information for a detailed inventory of written agreements and to compare arrangements or agreements with the data sharing requirements outlined in Appendices D- F.

As a result, the inventory in Appendix G is a summary of the types of arrangements or agreements among the three branches of State government and between specific branches and the Federal government, local government, and non-government entities. Additional information is available related to arrangements or agreements of the Executive branch and interested legislative committees and committees are encouraged to contact the Vermont State Archives and Records Administration.

FINDINGS AND RECOMMENDATIONS

Personally identifiable information, as defined in 9 V.S.A. § 2430, and street addresses, e-mail addresses, telephone numbers, and/or demographic information are often necessary to obtain and collect to protect the health, safety and rights of, and to provide services to, Vermont residents. In compiling and auditing Vermont Statutes Annotated, Code of Vermont Rules (Administrative Rules), Court Rules, and Administrative Orders of the Supreme Court pursuant to Section 1 of Act 89 (2020), the extent to which legislators and rulemaking bodies have thoughtfully balanced data collection needs with the Public Records Act or, where applicable, the Court Rules to Public Access to Court Records is palpable.

Legislators and rulemaking bodies have also incorporated in Vermont state laws and rules applicable Federal privacy and health information laws and regulations that relate to records and information produced or acquired by Vermont public agencies. In terms of personally identifiable information, relevant Federal acts include but are not limited to:

- Driver's Privacy Protection Act of 1994, as amended;
- Health Insurance Portability and Accountability Act of 1996, as amended; and
- Privacy Act of 1974, as amended

While State statutes and rules are not always amended to reflect the most recent Federal and State legislation regarding personally identifiable information (PII) or protected personally identifiable information (protected PII), the term often used to represent subsets of PII that are

generally exempt from public inspection or copying by Federal or state laws, the inventories compiled for this report provide a good foundation for further analysis.

In total, approximately 370 state statutes and 150 administrative or court rules (including administrative orders of the Supreme Court) requiring the collection and management of one or more of the data elements defined as personally identifiable information (PII) in 9 V.S.A. § 2430 or the collection and management of street addresses, e-mail addresses, telephone numbers, and/or demographic information were identified. The appendices also contain a further breakdown of specific Vermont public agencies and their relationships to each statute or rule based on the following aggregated Act 89 data elements (enumerated by the number of statutes or rules):

Recommendations

As the General Assembly continues its review and analyses of personally identifiable information (PII) and assesses risk related to PII collected and managed by Vermont state government, including which PII should be protected and therefore exempt from public inspection and copying under the Vermont Public Records Act – the following are suggested:

- 1) To promote uniformity and also support compliance with relevant Federal acts and regulations as they pertain to Vermont state government and public agencies as a whole, the

General Assembly adopt or adapt terms and definitions similar to terms and definitions adopted by the Federal government for personally identifiable information (PII), protected personally identifiable information (Protected PII), and other forms of PII.

- 2) To perform the necessary case-by-case assessments of risk, the General Assembly refer bills related to personally identifiable information produced or acquired in the course of Vermont state government and public agency business to the respective committees of jurisdiction for matters relating to the Judicial branch, the Legislative branch, and individual offices, agencies and department of the Executive branch, and also refer bills related to overarching personally identifiable information requirements for public records, especially if the bill proposes an exemption, to the House and Senate Committees on Government Operations.
- 3) To facilitate the understanding of the context in which personally identifiable information is produced or acquired in the course of Vermont state government and public agency business and to support compliance of related legislation by Vermont state government and public agencies, the General Assembly:
 - a. Separate legislation related to the collection and management of personally identifiable information by Vermont state government and public agencies from the legislation related to the collection and management of personally identifiable information by non-government entities; and
 - b. Transition from using Title 9 (Commerce and Trade) to Title 1 for overarching provisions as they pertain to personally identifiable information in public records produced or acquired in the course of Vermont state government and public agency business; and to specific titles if the personally identifiable information in public records pertains to only certain subdivisions of Vermont State government or local government.
- 4) To clarify recent additions and amendments to Title 9 (Commerce and Trade), particularly Chapter 62 (Protection of Personal Information), as they pertain to Vermont state government and public agencies, the General Assembly:
 - a. Revisit additions and amendments made in Act 89 within the context of the suggestions made in this report, including amendments made to the definition of personally identifiable information in 9 V.S.A. § 2430 to include health information without the specificity of discrete digital data elements; and
 - b. Address health information, particularly protected health information (PHI), produced or acquired in the course of Vermont state government and public agency business separately from the other forms of personal information but also within the context of the suggestions made in this report.

APPENDIX D: DATA ELEMENTS IN VERMONT STATUTES ANNOTATED

An inventory of Vermont Statutes Annotated that reference the collection and management of personally identifiable information data elements, as defined in 9 V.S.A. § 2430, and of street addresses, e-mail addresses, telephone numbers, and demographic information, by the Executive, Judicial and Legislative branches of Vermont State government.

The listing in Appendix D uses the definition of public agency as defined in 1 V.S.A. § 317, which is: “agency, board, department, commission, committee, branch, instrumentality, or authority of the State or any agency, board, committee, department, branch, instrumentality, commission, or authority of any political subdivision of the State.”

As requested in Section 1 of Act 89, the following information for each data element, within the context of the public agency referenced in the statute, is included in the listing below:

- **Exempt:** Whether the data element is exempt from public inspection and copying under the Public Records Act;
- **Exchange:** Whether the statute requires the agency to exchange or share the data element with another party; and
- **Agreement:** Whether the statute requires the agency to have an agreement for exchanging or sharing the data element.

Important Note: This inventory *includes* statutes that reference non-specified “addresses,” meaning that the statute does not specify whether the address is a street address or mailing address. This inventory *does not include* non-data elements that were added to the definition of personally identifiable information in 9 V.S.A. § 2430 by Act 89, specifically:

- Genetic information;
- Health records or records of a wellness program or similar program of health promotion or disease prevention; and
- Health care professional's medical diagnosis or treatment of the consumer.

APPENDIX E: DATA ELEMENTS IN ADMINISTRATIVE RULES

An inventory of Code of Vermont Rules (Administrative Rules) that require the collection or management of personally identifiable information data elements, as defined in 9 V.S.A. § 2430, and of street addresses, e-mail addresses, telephone numbers, and demographic information, by the Executive branch of Vermont State government.

The listing in Appendix E uses the definition of public agency in 1 V.S.A. § 317, which is: “agency, board, department, commission, committee, branch, instrumentality, or authority of the State or any agency, board, committee, department, branch, instrumentality, commission, or authority of any political subdivision of the State.”

As requested in Section 1 of Act 89, the following information for each for data element, within the context of the public agency referenced in the statute, is included in the listing below:

- **Exempt:** Whether the data element is exempt from public inspection and copying under the Public Records Act;
- **Exchange:** Whether the statute requires the agency to exchange or share the data element with another party; and
- **Agreement:** Whether the statute requires the agency to have an agreement for exchanging or sharing the data element.

Important Note: This inventory *does not include* non-specified “addresses;” only rules specifying street address are included in this inventory. This inventory also *does not include* non-data elements that were added to the definition of personally identifiable information in 9 V.S.A. § 2430 by Act 89, specifically:

- Genetic information;
- Health records or records of a wellness program or similar program of health promotion or disease prevention; and
- Health care professional's medical diagnosis or treatment of the consumer.

APPENDIX F: DATA ELEMENTS IN COURT RULES

An inventory of data elements in Court Rules and Administrative Orders of the Supreme Court that require the collection or management of personally identifiable information data elements, as defined in 9 V.S.A. § 2430, and of street addresses, e-mail addresses, telephone numbers, and demographic information, by the Judicial branch of Vermont State government.

The listing in Appendix F uses the definition of public agency in 1 V.S.A. § 317, which is: “agency, board, department, commission, committee, branch, instrumentality, or authority of the State or any agency, board, committee, department, branch, instrumentality, commission, or authority of any political subdivision of the State.”

As requested in Section 1 of Act 89, the following information for each data element, within the context of the public agency referenced in the statute, is included in the listing below:

- **Exempt:** Whether the data element is exempt from public inspection and copying under the Public Records Act;
- **Exchange:** Whether the statute requires the agency to exchange or share the data element with another party; and
- **Agreement:** Whether the statute requires the agency to have an agreement for exchanging or sharing the data element.

Important Note: This inventory *does not include* non-specified “addresses;” only rules specifying street address are included in this inventory. This inventory *also does not include* non-data elements that were added to the definition of personally identifiable information in 9 V.S.A. § 2430 by Act 89, specifically:

- Genetic information;
- Health records or records of a wellness program or similar program of health promotion or disease prevention; and
- Health care professional's medical diagnosis or treatment of the consumer.

APPENDIX G: ARRANGEMENTS OR AGREEMENTS (WRITTEN OR VERBAL)

The Legislative branch reports no collection and management of any of the aggregated data elements and therefore no agreements, written or verbal, related to data sharing or data exchanges. This is consistent with the audit of State statutes and rules, which found no requirements for the Legislative branch pertinent to this report.

The Judicial branch reports data sharing and data exchanges with the Executive branch under specific statutes, which are consistent with the inventories included in the appendices. Related to written agreements, the Judicial noted that it has memoranda of understanding with the Department for Children and Families and the Department of Corrections as authorized under the *Rules for Public Access to Court Records* for the routine exchange of data elements as they relate to juveniles and offenders.

Executive branch record officers representing state offices, state agencies and state departments responded to an online survey to help determine if agreements, whether written or verbal, exist between branches of state government or between branches of state government and the Federal government, local government, or non-government entities to routinely share or exchange any of the following specific data elements:
