10	§ 651. LEGISLATIVE ADVISORY COMMITTEE ON THE STATE
11	HOUSE
12	(a) The Legislative Advisory Committee on the State House is created.
13	(b) The Committee shall be composed of 13 11 members:
14	(1) four three members of the House of Representatives, appointed
15	biennially by the Speaker of the House;
16	(2) four three members of the Senate, appointed biennially by the
17	Committee on Committees;
18	(3) the Chair of the Board of Trustees of the Friends of the Vermont
19	State House;
20	(4) the Director of the Vermont Historical Society;
21	(5) the Director of the Vermont Council on the Arts Arts Council;

1	(6) the Commissioner of Buildings and General Services or designee;
2	<mark>and</mark>
3	(7) the Sergeant at Arms.
4	(c) The Committee shall biennially elect a chair from among its legislative
5	members. A quorum shall consist of seven six members.
6	(d) The Committee shall meet at the State House at least one time when the
7	General Assembly is in session and at least one time when. When the General
8	Assembly is not in session or at the call of the Chair, the Committee shall meet
9	at least one time, but the Committee and any subcommittees shall not
10	cumulatively meet more than six times per year; provided, however, that the
11	Committee and any subcommittees of the Committee may meet more often
12	with the approval of the Speaker of the House and the President Pro Tempore
13	of the Senate. The Commissioner of Buildings and General Services shall
14	keep minutes of the meetings and maintain a file thereof.
15	(e) The Committee shall have the assistance of the Office of Legislative
16	Counsel and the Office of Legislative Operations.
17	§ 652. PER DIEM AND EXPENSES; LEGISLATIVE MEMBERS
18	For meetings held during adjournment of the General Assembly, the
19	legislative members of the Committee shall be entitled to per diem
20	compensation and expense reimbursement as provided in subsection 406(a) of
21	this title.

1	§ 653. FUNCTIONS
2	(a)(1) The Legislative Advisory Committee on the State House shall be
3	consulted on :
4	(1) review, coordinate, and make recommendations on all activities
5	relating to the acquisition collections and care of paintings and art, historic
6	artifacts, and furnishings, and the refurbishing, renovation, preservation, and
7	expansion of the building and its interior-; and
8	(2) The Legislative Advisory Committee on the State House shall
9	develop approve a plan for the acquisition or commission of artwork
10	collections policy for the State House art collection that represents Vermont's
11	diverse people and history, including diversity of gender, race, ethnicity,
12	sexuality, and disability status, as developed by the State Curator pursuant to
13	29 V.S.A. § 154a(c).
14	(b) The Sergeant at Arms and the Commissioner of Buildings and General
15	Services, in discharging responsibilities under subdivision 62(a)(6) of this title
16	and 29 V.S.A. §§ 154(a) and 154a, respectively, shall consider the
17	recommendations of the Committee. The Committee's recommendations shall
18	be advisory only.
19	Sec. 2. 2 V.S.A. § 62 is amended to read:
20	§ 62. LEGISLATIVE DUTIES
21	(a) The Sergeant at Arms shall:

1	(1) execute orders of either house, the Joint Legislative Management
2	Committee, the Committee on Joint Rules, or the House or Senate Committee
3	on Rules;
4	(2) maintain order among spectators and take measures to prevent
5	interruption of either house or any committee thereof;
6	(3) arrange for special meetings and conferences at the State House;
7	(4) provide for the distribution of mail to all legislators;
8	(5) schedule the time for the use of rooms for committee meetings and
9	hearings;
10	(6) maintain the State House and its furnishings in a good state of repair
11	and provide security for all furniture, draperies, rugs, desks, and other
12	furnishings kept in the State House in consultation with the State Curator;
13	(7) provide for the establishment of a cafeteria and supervise its
14	operation;
15	(8) provide security for the State House, pursuant to the responsibilities
16	set forth in 29 V.S.A. § 171; and
17	(9) perform such other duties for the benefit of the legislators as may be
18	required by any duly authorized committee thereof.
19	(b) He or she or any person in his or her employ shall not accept any
20	compensation or gift for his or her services other than his or her salary. If he

1	or she or any person in his or her employ violates this provision, he or she shal
2	be fined \$25.00.
3	(c) The Sergeant at Arms shall not be responsible for
4	(1) structural repairs, or capital improvements, to or building
5	maintenance for of the State House (as the term maintenance is defined in
6	29 V.S.A. § 159) <u>:</u>
7	(2) curating the historic State House and its collections: or for
8	(3) the use, upkeep, or maintenance of the State House grounds.
9	(d) The Sergeant at Arms and employees of the Sergeant at Arms shall seek
10	guidance from and operate in accordance with policies adopted by the Joint
11	Legislative Management Committee.
12	Sec. 3. 29 V.S.A. § 154a is amended to read:
13	§ 154a. STATE CURATOR
14	(a) Creation. The position of State Curator is created within the
15	Department of Buildings and General Services.
16	(b) Duties. The State Curator's responsibilities shall include:
17	(1) oversight of the general historic preservation of the State House,
18	including maintaining the historical integrity of the State House and works of
19	art in the State House;
20	(2) interpretation of the State House to the visiting public through
21	exhibits, publications, and tours, and other means of communication; and

1	(3) acquisition, management, and care of State collections of art and.
2	historic artifacts, and furnishings, provided that any works of art all items
3	obtained for the State House are acquired pursuant to the requirements of
4	2 V.S.A. § 653(a) collections policy adopted pursuant to subsection (c) of this
5	section; and
6	(4) oversight and management of the State's historic and contemporary
7	art and collections in other State buildings and on State property.
8	(c) Acquisition Collections policy. In coordination with the Legislative
9	Advisory Committee on the State House, and in accordance with the plan
10	developed pursuant to 2 V.S.A. § 653, the The State Curator shall adopt an
11	acquisition develop a collections policy that ensures that the acquisition of art.
12	historic artifacts, and furnishings, and the commissioning of art and
13	furnishings, for the State House reflects Vermont's diverse people and history,
14	including a diversity of gender, race, ethnicity, sexuality, and disability status,
15	and a diversity of artistic media and artists, and celebrates the natural history of
16	the State, and the diversity of the people and stories of Vermont throughout the
17	history of the State. Upon approval of the Legislative Advisory Committee on
18	the State House pursuant to 2 V.S.A. § 653, the State Curator shall adopt the
19	collections policy.
20	(d) Interpretive plan. In coordination with the Friends of the Vermont State
21	House and the Vermont Historical Society, the State Curator shall create an

1	interpretive plan that tells the stories of the State House art collection through
2	accessible written, multimedia, and oral means. The plan shall include
3	appropriate and inclusive training of State House volunteers and staff.
4	Sec. 4. EFFECTIVE DATE
5	This act shall take effect on passage, except that all legislator members of
6	the Legislative Advisory Committee on the State House on that date shall
7	remain on the Committee through the end of the 2021-2022 biennium, and the
8	Committee shall not approve a collections policy pursuant to 2 V.S.A.
9	§ 653(a)(2) until the members for the 2023–2024 biennium have been
10	<mark>appointed</mark> .
